

Resolution No. 18400

WHEREAS in the matter of the proposed ~~opening~~, widening and extension of Broadway, from Crosby Street to Wheeler Street; Larrabee Street, from Broadway to Delay Street; Williams Avenue, from Broadway to Holladay Avenue; Broadway, from East First Street to Union Avenue; Weidler Street, from Wheeler Street to Broadway; Wheeler Street, from Broadway to Hancock Street; Hancock Street, from Flint Street to Ross Street; Multnomah Street, from East First Street to Ross Street; Benton Street, from Clackamas Street to Williams Avenue and Cherry Street, from Wheeler Street to Weidler Street, pursuant to Resolution No. 17242, the full amount has been received in the City treasury sufficient to pay the damages awarded for property taken; therefore

BE IT RESOLVED that said Broadway, Larrabee Street and Williams Avenue, et al, described in said resolution as widened and shown on the City Engineer's report filed in said matter, be and the same are hereby declared to be opened, laid out and established as city streets as provided by Ordinance No. 53027, adopting said report;

BE IT FURTHER RESOLVED that the City Engineer be and he is hereby instructed to record with the County Clerk of Multnomah County, Oregon, within ninety days after the adoption of this resolution a copy of this resolution and a map of said street widening.
