

Resolution No. 21393 -2

WHEREAS, it appears to the Council that Multnomah county, Oregon, by its Commissioners, entered a final order, dated the 3rd day of November, 1937, surrendering to the City of Portland its jurisdiction over the following described county roads:

N.W. St. Helens Road: All of N.W. St. Helens Road from the beginning of Road No. 1132, as established, to the northerly limits of the City of Portland, comprised of the following:

All of N. W. St. Helens Road No. 1132, as established, from the beginning near the east line of N. W. 31st Avenue to the center of F Street in Linnton, including the west approach to the St. Johns bridge, and any unvacated portions of roads Nos. 62, 395, 482, 603 and 851.

All of road No. 1122, as established, including <sup>any</sup> unvacated portions of Roads Nos. 395, 482 and 874.

S. W. Canyon Road: All of S. W. Canyon Road No. 1138, as established, from the beginning, the extended line of Blocks 9 and 15, Amos N. King's Addition to the westerly limits of the City of Portland.

S. W. Capitol Highway: All of S. W. Capitol Highway, No. 1050, as established, from the beginning of S. W. Terwilliger Boulevard to the westerly city boundary.

S. W. Slavin Road: All of that portion of S. W. Slavin Road, No. 1148, from the intersection with S. W. Barbur Boulevard, westerly to the end of Road No. 1148 at its intersection with S. W. Capitol Highway, No. 1050 and S. W. Terwilliger Boulevard.

S. W. Riverside Drive: (S.W. Macadam Ave.) All of S. W. Riverside Drive, No. 680, as established, from S. W. Virginia Street to the southerly city boundary, including the south bound road and west approach to the Sellwood bridge.

N. Denver Avenue: All of N. Denver Avenue, No. 1368 and 905, as established, from the beginning 198.78 feet north of the center line of N. Argyle Street to the northerly city boundary.

N. Interstate Avenue: All of that portion of N. Interstate Avenue (Old St. Johns River Road No. 932) from N. Morris Street to N. Russell Street.

S. E. 82nd Avenue: All of that portion of S. E. 82nd Avenue, being country roads Nos. 575 and 488, from S. E. Division Street south to the southerly city boundary.

A copy of said order has been filed with the auditor, and said order has been made and entered after full compliance by the Board of County Commissioners with the statutes of the State of Oregon governing the surrender of county roads to municipalities; and

WHEREAS, no award of damages has been made, inasmuch as no damages have been sustained by any one, and there has been no assessment of benefits, inasmuch as no damages have been awarded, and it appears to the Council that said county roads should be laid out, taken over and established as city streets; now, therefore, be it

RESOLVED by the Council of the City of Portland, Oregon, that said portions of said county roads be and the same are hereby taken over, laid out and established as city streets, and the City of Portland from this time forward shall have exclusive jurisdiction and control of said portions of said county roads.

BE IT FURTHER RESOLVED that the auditor forward to the County Commissioners of Multnomah county, Oregon, a copy of this resolution.
