Accept grant in the amount of \$1,200,000 and appropriate \$120,350 for FY 2022-23 from the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance National Sexual Assault Kit Initiative FY 2022 for Sexual Assault Management System enhancements and deployment

The City of Portland ordains:

Section 1. The Council finds:

1. The City applied to the U.S. Department of Justice (DOJ), Office of Justice Programs (OJP), Bureau of Justice Assistance (BJA) for the National Sexual Assault Kit Initiative (SAKI) FY 2022 Competitive Grant on June 1, 2022;
2. The Office of Justice Programs has notified the City that it will award a grant for the National SAKI FY 2022 Competitive Grant to the City in the amount of \$1,200,000;
3. This grant will support continued work on the Sexual Assault Management System (SAMS) developed using prior SAKI grants;
4. The grant period is October 1, 2022, through September 30, 2025;
5. No match is required by this grant.

NOW, THEREFORE, the Council directs:

- A. The Mayor is hereby authorized to accept on behalf of the City a grant from BJA for the FY 2022 National Sexual Assault Kit Initiative Competitive Grant in the amount of \$1,200,000 and to execute the grant agreement.
- B. The FY 2022-23 budget is hereby amended as follows:

Any modifications that increase the City's financial obligation or risk must be authorized by the Council.

Impact Statement

Purpose of Proposed Legislation and Background Information

This ordinance allows the Portland Police Bureau to accept and appropriate the FY 2022 National Sexual Assault Kit Initiative (SAKI) grant to continue the important work of supporting the Sexual Assault Management System (SAMS) developed under previous SAKI funding.

The Portland Police Bureau used SAKI funding awarded in 2015, 2016, and 2018 to test their backlog of 1,754 unsubmitted sexual assault kits, investigate 169 cold cases leading to 18 prosecutions and counting, develop victim-centered training materials and best practices, and build a suite of software tools collectively known as SAMS. This software tracks sexual assault kits, provides

case management for detectives, and delivers much-needed transparency to survivors tracking the status of their kits. SAMS is currently being used by 18 agencies across the country.

The focus of the FY 2022 grant award will go towards continuing to support and develop SAMS as well as establishing a plan to sustain SAMS beyond the life of the grant.

Financial and Budgetary Impacts

This action will increase the Police Bureau’s Grant Fund appropriation by \$120,350 for FY 2022-23. There is no match required by this grant.

Community Impacts and Community Involvement

SAKI sites throughout the country will benefit from the Sexual Assault Management System (SAMS) enhancements and deployment.
