Council members and Mayor Wheeler,

My name is Bryan M. Vance, and I am a homeowner on SE 89th Avenue. My girlfriend and I bought this 800-square-foot home, our first, in November 2021.

Our house sits across from Berrydale Park and the Creative Sciences School. Living on this street, we've experienced first-hand the problems caused by poor public infrastructure on SE 89th Avenue. We've spent thousands of dollars to prevent stormwater from flooding our driveway. While walking our dog, we've had many close calls with cars driving by due to the lack of sidewalks. We watch students and parents vie with those same cars every day as they enter and leave school. Something needs to change.

I want to be very clear: We need safe sidewalks on our street. I am a disabled person. My sister is a disabled person. I grew up with direct knowledge of the unfair fight disabled people must put up to get even basic needs met. Often, we're forced to make due with what others decide is best for us. Those decisions are usually made without our input.

That is why this LID project the city is forcing on our street is so frustrating. We did not ask for this. The people of color, immigrants, and pensioners who own homes on this street get almost no say in how this project happens. And due to a city-owned park being involved, this very Council can overrule what little say we have. We are being told we have no choice but to go along. And as Mr. Andrew Aebi has made clear, the city's policy is: Don't like it? Move.

But where are we supposed to move? We settled in East Portland because it was one of the only places we — a couple made up of a then nonprofit worker and an immigrant — could afford. Much of East Portland deals with similar issues to what we experience on SE 89th Avenue.

But the lack of safe, modern infrastructure is actually a city-wide problem. Portland contains more than 55.1 miles of unpaved streets. Similar numbers about streets lacking sidewalks are hard to come by, but we all know the rate is far from acceptable. Portland makes it difficult for people to safely move about. Even streets with sidewalks often lack ADA-compliant curb ramps.

I am in agreement with you all that we need improved public infrastructure. People are dying on our streets as a direct result of the sorry state of our roads. We need to fix this. But that is where my agreement with Portland's leadership ends.

This city, for decades, has failed to make systemic, fair changes to address these problems. Now, rather than using tools — such as public works bond measures to raise the funds necessary to improve all of our roads — that could make a more meaningful impact in a more equitable way, the city is forcing myself and my neighbors to foot a hefty bill to pay for past civic mistakes. To pretend this is the only way forward is dishonest. To force citizens to pay directly for costly public infrastructure projects to the tune of \$24,000, plus interest, per household is inequitable. It's poor leadership. And it creates a patchwork solution to a systemic problem.

As I've already stated and as Mr. Aebi has made abundantly clear, we likely have little to no say in this project getting approved. But I'd highly encourage you to consider how you can best serve ALL of Portland by taking a smarter, more fair approach in the future. We could fix our streets city-wide. We lack the initiative at the leadership level to do so.

Commissioner Hardesty, Mayor Wheeler, and the rest of the Portland City Council,

It is with the utmost respect that I write in to formally acknowledge my opposition to the LID project for SE 89th Avenue and SE Taylor Street as it's currently written. Also, I would like to formally lodge a complaint about Mr. Andrew Aebi's handling of this entire project.

Due to Mr. Aebi having an innacurate address listed for where to submit remonstrance as recently as Nov. 20 (well into the project's existence), I inadvertently sent my letter to the wrong Portland city address. His failure to keep the relevant documentation updated led to my and my partner's voice not being heard on this issue. Our rights as Portland voters were trounced upon.

Further, Aebi has not communicated openly with us or our neighbors about this project. Information has had to been gathered through media reports and individual requests to Aebi by our neighbors. He did not proactively reach out to affected property owners following the first Council hearing. No one from the city did. If not for some diligent neighbors, I and most of my fellow 89th Avenue residents would not have known when the next hearing was happening.

A Willamette Week article by Sophie Peel was the first time my neighbors and I were presented with Aebi's proposed costs for this project. He has been disrespectful and dismissive of the real economic impact this project, as he has defined it, will have on the very East Portlanders he claims to be working to help.

It is with the utmost respect and sincerity that I urge you to not approve this LID as it's currently defined. Decades of poor leadership and management at the County and City level created the situation playing out on SE 89th Avenue (and streets across our city). A lack of the political ambition to do what's right and address the systematic inequities and dangerous conditions those very mistakes perpetuated leads to a continuing patchwork process to fixing our streets, and unduly puts the financial burden on low and middle income residents.

If the city is serious about utilizing the economic power of economies of scale, why limit this project to such a small area? Why not tackle all the problem streets in the 97216 ZIP code with a bond measure and federal grants? Why not get serious about creating a safer city for all Portlanders today? Why not dream bigger?

Again, I urge you to dig deep and find the political courage to do what is right here. Vote against the LID proposal as it currently stands. Encourage Aebi to serve all Portlanders, and to do so with respect, compassion, and competency.
