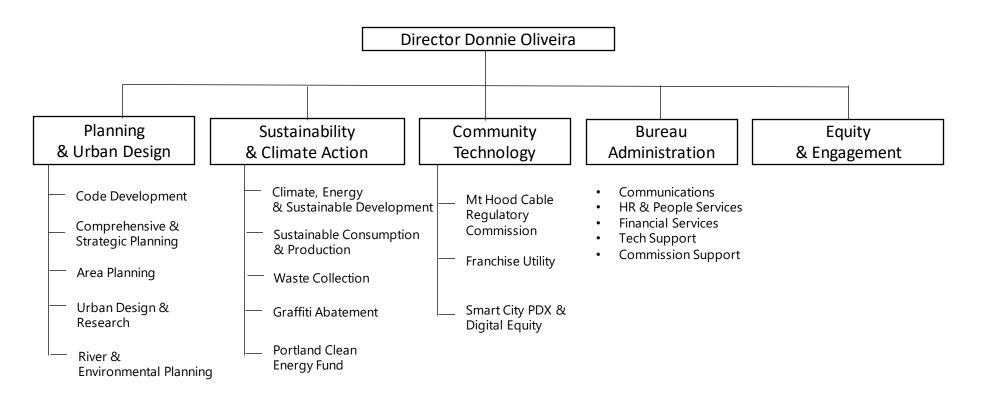
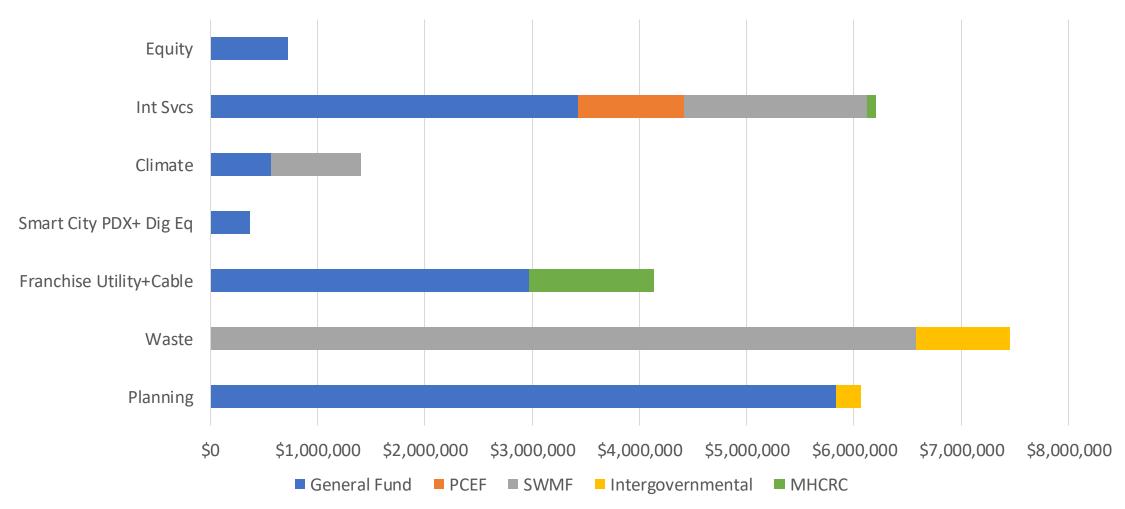

Budget Instructions

- No General Fund (GF) cuts requested
- No new ongoing GF requests permitted
- No new GF one-time requests permitted
- Non-GF programs (PCEF ad SWMF) may make changes
- Technical/cost neutral GF adjustments allowed
- Phase 2 coming in 2023, by portfolio bundles
 - One-time requests could be allowed then, based on priorities agreed to by the Commissioner
- Carry over of two-year appropriations and ARPA will be handled in SpringBMP



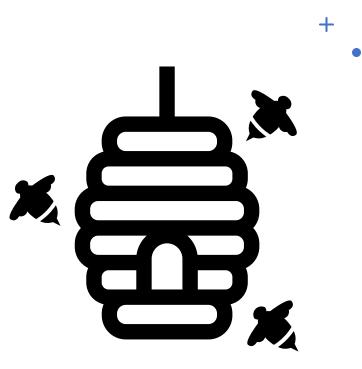
Opportunities

- Absorption of OCT and Graffiti brings some opportunity to optimize work with existing resources
- PCEF resources will allow that program to add staff in response to new code parameters and direction for programmatic investments
- Waste Program will consider code change in 2023
- Planning, Smart Cities and Climate received large one-time 2-year appropriations last year (no need for new requests in FY 23/24)
- OCT will move to Vanport in July reduces rent costs for the bureau



Issues/Challenges

- Graffiti Program needs ongoing CAL adjustment, and ongoing funding for manager (funded on one-time resources in 21/22)
- Public trash and graffiti work is still disproportionately funded by onetime resources that will dry up by 2024.
- Age Friendly Program funding ending June 2023
- Additional Internal Services capacity needed (Finance, HR, Tech Svcs., Comms)
- Privacy policy brings ongoing resource needs
- Hybrid work increases some technology costs
- Additional space planning one-time costs expected
