An Ordinance to amend  
Ordinance No. 4998, entitled "An  
Ordinance to permit Chinese to  
burn firecrackers during their  
New Year"

The City of Portland does ordain  
as follows:

Section 1, That Ordinance No. 4998  
of the City of Portland entitled "An  
Ordinance to permit Chinese to burn  
fire-crackers during their New Year"  
Approved January 6, 1887, be and the  
same is hereby amended so as to  
read as follows:

Section 1, That the Chinese of the  
City of Portland be allowed to burn  
fire-crackers during their New Year  
commencing January 22, 1887 and  
ending February 2, 1887, between the  
hours of 6 and 7<sup>30</sup> o'clock A. M. and 6 and  
8 o'clock P. M. Sundays excepted.

Provided they may burn fire-crackers  
on the 23<sup>d</sup> day of January 1887 before  
and up to 7 o'clock A. M. and between  
the hours of 6 and 7 o'clock P. M. of  
said day.
