As you probably know by now, there has been a lot happening in the Errol Heights Community this past summer.

- * Errol Heights was included, initially, in the Milwaukie area consolidation proposal. The Metropolitan Boundary Commission subsequently withdrew Errol Heights from this proposal.
- * A partial annexation to the City of Portland was proposed for the area of Errol Heights served by Community Water Company. This partial annexation was opposed by the Executive Board of EHCA because it would have split our area into three parts. As a consequence, the Metropolitan Boundary Commission disapproved the proposal and voted to initiate a proposal to annex the entire Errol Heights area to the City of Portland.

The public hearing on this proposal is scheduled for September 18, 1980, presumably at the County Courthouse.

- * At the June meeting of the Errol Heights Community Association, the members voted to set up a task force to study the various alternatives available to Errol Heights. This task force will present the findings available at this time. They have had a meeting with Portland City officials to negotiate for benefits, as an investigative tool.

These matters will be discussed at the upcoming meeting of the Association. We are limited to time during our meeting at the school and must be out of the building by 9:30. Because of this, we will begin promptly at 7:30 p.m. Please plan to be there and become an informed citizen.

We feel that these panels will be able to answer your questions and provide the necessary information for you to make an intelligent choice on February 17.
