ORDINANCE No.

Public Recreational Areas Fund, appropriation Improvement and Development of Land, Code No. 5600.785, is hereby made available to apply on the above authorized purchase. Purchases shall be charged to the General Fund appropriation until it is exhausted. Remaining purchases shall be charged to the Fublic Recreational Areas Fund appropriation.

Section 3. The installation of the materials authorized to be purchased in Section 1. above shall be made by the Portland Metropolitan Softball Association subject to the approval of the Superintendent of Parks and at no cost to the City of Portland. The furnishing of labor and materials and the expenditure of funds by the Portland Metropolitan Softball Association in connection with the installation of supplemental lighting at Normandale Park shall not be construed as giving or granting any special privilege or conveying any property right to the association or to any person or persons whomsoever.

Section 4. The provisions of this ordinance shall not be operative until there shall have been filed with the Auditor of the City of Portland an acceptance of the terms and conditions of this ordinance duly executed by the Portland Metropolitan Softball Association, Don Derr, President, 6105 N. Campbell Street, Portland, and Ralph Holsapple, General Chairman of the Championship Tournament Committee.

Section 5. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: That it is necessary to authorize the purchase of the materials described in Section 1. above and to provide for their installation immediately; therefore, an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.

An Ordinance authorizing the purchase of necessary materials for supplementing the lights at the Normandale Park Softball Field, in the open market without advertising for bids, making a transfer of \$3,000 within the General Fund from Emergency and Unforeseen Expenditures to the Bureau of Parks, making appropriation in the amount of \$3,000 in the Public Recreational Areas Fund also available to apply on said purchase, authorizing the drawing of warrants, requiring the installation of said lighting materials by the Portland Metropolitan Softball Association, providing for acceptance of the conditions of this ordinance by the Portland Metropolitan Softball Association, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Council finds that Ordinance No. 113819, passed by the Council July 12, 1961, authorizes the use of Normandale and Farragut Parks by the Portland Metropolitan Softball Association for staging the 1961 Women's World Championships of the Amateur Softball Association scheduled to begin August 25, 1961; that it has been found necessary to supplement the lighting at Normandale Park in order to provide an adequate level of illumination for night games; that the Portland Metropolitan Softball Association, through its Tournament Committee, Ralph Holsapple, Chairman, has offered to provide the installation of the supplemental lighting at no cost to the City if the City will purchase the necessary materials; that it would be in the best interest of the City of Portland to purchase such necessary materials as are specified by the Bureau of Parks at an estimated total cost of \$6,000; and that it is necessary to purchase such materials in the open market without advertising for bids in order to complete the installation price to the opening date of said championships; now, therefore, the purchase of necessary materials for installation of supplemental lighting at the softball field in Normandale Park is hereby authorized in the open market without advertising for bids at a cost not to exceed \$6,000. The Mayor and the Auditor are hereby authorized to draw warrants on the appropriations listed in Section 2. below in payment for said lighting materials when demands therefor are presented approved by the proper authority.

Section 2. In order to provide funds for the purchase of the materials described in Section 1. above, the sum of \$3,000 is hereby transferred within the General Fund from the appropriation Emergency and Unforeseen Expenditures, Code No. 4100, to the appropriation Bureau of Parks, Park Maintenance Division, Improvements and Development of Land, Code No. 1840.785, and the sum of \$3,000 presently budgeted in the Aud. 50-25-640 5-61-2M
