Thank you, Kyle Steinhauer Hello there, my name is Kyle Steinhauer. I'm a graduate student, a social worker, and someone who cares about how government policy impacts the vulnerable within our society. I wanted to write my testimony on the recent actions taken by Portland City Commissioner Rene Gonzalez

On February 14<sup>th</sup>, Commissioner Gonzalez ordered all bureaus he oversees to stop handing out both tents and tarps to members of the public. Gonzalez stated in his press release that this was because tent and tarp-related fires were a "...grave public safety emergency for our city." Gonzalez approved those bureaus to continue handing out sleeping bags and blankets, though this is clearly lacking. When warming shelters in Portland refuse to open unless one of several conditions are met (forecasted temperature of 25 degrees Fahrenheit or below, forecasted snow accumulation of 1 inch or more, forecasted temperature at or below 32 degrees Fahrenheit with "driving rain" of 1 inch or more overnight)², this leaves the approximately 3,800 people just within the city itself who are homeless with no options to stay warm besides a sleeping bag and blanket.³ This is not to mention that the county hosts a total of 2,000 shelter beds,⁴ meaning that Commissioner Gonzalez's order has essentially condemned thousands of people to unsheltered sleeping in dangerous conditions.

Given that Commissioner Gonzalez proudly advertises that, if elected, he will immediately "Prioritize emergency shelter...",<sup>5</sup> this leads one to ask why he would ban tents and

tarps while doing nothing to increase shelter capacity in the city. It seems that, rather than focusing on the safety of the most vulnerable in our city, he has chosen to punish them for being homeless. It makes one wonder if Commissioner Gonzalez would be willing to spend a night on the streets of Portland himself with just a sleeping bag and blanket, to let us know that he cares for those "...thousands of vulnerable unsheltered..." in Portland – especially those who are unable to access warming centers due to lack of space.

Fate and circumstance seem to have worked together to ensure that Commissioner Gonzalez's ban would be especially brutal to our most vulnerable in Portland, as we experienced the second-most snow in the city's recorded history with 10.8 inches on Wednesday, February 22<sup>nd</sup>. <sup>6</sup> This is on top of the weather dipping down to the low-20 degrees Fahrenheit that night.<sup>7</sup>

I strongly question the actions taken by Commissioner Gonzalez and urge him to repeal his ban on tents and tarp distribution in Portland. His actions have unduly punished the most vulnerable members of our society, subjected them to being defenseless against a brutal winter storm, and were made with no improvements made to the alternative options available. I am concerned with the actions of government officials who talk out both sides of their mouth — claiming to be deeply concerned with the welfare of the homeless population, while stripping them of the ability to stay warm in one of the coldest nights in recorded history.
