Code Section 705.8.6.2 Vertical Exposure for Buildings on Separate Lots

RequiresWhere a new building is to be erected adjacent to an existing building, all opening protectives in the exterior wall of the new building are required to have a fire protection rating of not less than 3/4

hour where these opening protectives are less than 15ft vertically above the roof of the existing

building or structure.

Code Modification or Alternate Requested Employing Type 13 water curtain sprinklers in lieu of providing rated windows.

Proposed Design

There are two proposed operable windows marked R on the attached building elevation at the second floor within 15' of existing houses on the adjacent lot. These operable windows are proposed to be non-rated with dedicated Type 13 water curtain sprinkler heads on the interior side. Each opening will have sprinkler heads spaced not more than 6 feet apart. The sprinkler heads will be a minimum of 6" and maximum of 12" from the window, and a maximum of 12" below the

ceiling. No mechanical openings are proposed in the affected areas.

Reason for alternative Dedicated sprinkler heads at operable windows will serve the goal of protecting the openings from

the adjacent building, and vice versa. In this case, the additional sprinkler heads will provide an equivalent level of life safety as a 3/4 hour protected opening. The appeal is consistent with a

previously approved appeal on a similar project. (reference Appeal ID 25008)
