ORDINANCE NO. 23507

An ordinance providing for the change of the names of certain streets in the City of Portland.

The City of Portland does ordain as follows:

Section 1: The names of the streets within the corporate limits of the City of Portland, as hereinafter set forth, shall hereafter be known by the names as provided in said Section.

Section 2: That St. Helens Avenue in Sunrise Park and St. Thomas, be changed, and hereafter known as East Washington Street.

That Labor Avenue in Sunrise Park and St. Thomas, be changed and hereafter known as East Alder Street.

That Hood Avenue in Sunrise Park and St. Thomas, be changed and hereafter known as East Morrison Street.

That Jefferson Avenue in Sunrise Park, be changed and hereafter known as East Washburn Street.

That South Avenue in Sunrise Park be changed and hereafter known as East Taylor Street.

That Motor Avenue in Supplementary Plat of Mansfield, Stanley and Stanley No. 2, be changed and hereafter known as East Taylor Street.

That Division Street in North Fairlawn, be changed and hereafter known as Delano Street.

That Ball Street in Supplementary Plat of Mansfield, be changed and hereafter known as Delano Street.

That Alexander Street in Supplementary Plat of Mansfield Stanley and Stanley No. 2 be changed and hereafter known as East Main Street.

That Wallace Street in South Fairlawn, be changed and hereafter known as East Madison Street.

That Evelyn Street in Supplementary Plat of Mansfield Stanley and Stanley No. 2, be changed and hereafter known as Hawthorne Avenue.

That Roger's Street in South Fairlawn, be changed and hereafter known as Hawthorne Avenue.

That Newton Street in South Fairlawn, be changed and hereafter known as East May Street.

That Hunter Street in Terrace Park, be changed and hereafter known as East Ash Street.

That Guide Avenue in Monticello be changed and hereafter known as East Pine Street.

That First Street in Sabelville be changed and hereafter known as East Oak Street.

That Second Street in Mabelville, be changed and hereafter known as East Pine Street.

That Third Street in Mabelville, be changed and hereafter known as East Ash Street.

That Mt. Labor Avenue in Monticello, be changed and hereafter known as East Ankeny Street.

That Fourth Street in Mabelville, be changed and hereafter known as East Ankeny Street.

That Fifth Street in Mabelville, be changed and hereafter known as East Burnside Street.

That Olney Street in Terrace Park, be changed and hereafter known as East Davis Street.

That Columbia Avenue in Villa Hill, be changed and hereafter known as East Everett Street.

That Gray Avenue in Villa Hill, be changed and hereafter known as East Flanders Street.

That Villa Avenue from the County Road between sections 32 and 33, T. 1 N. R. 2 E. to the center of section 33 Township and Range as aforesaid, be changed and hereafter known as East Glisan Street.

That the County Road between sections 5 and 4, T. 1 N. R. 2 E. and between sections 32 and 33 and between sections 29 and 28 T. 1 N. R. 2 E. from section line Road to Fremont Street, be changed and hereafter known as East 82nd Street.

That Spanton Drive in Terrace Park be changed and hereafter known as East 83rd Street.

That Sheffield Drive in Terrace Park be changed and hereafter known as East 84th Street.

That Billinger Drive in Terrace Park from the north line of Base Line Road to a line drawn from the south corner of lot 2, Block 20 to the north west corner of lot 6, block 14, be changed and hereafter known as East 85th Street.

That Terrace Way in Terrace Park be changed and hereafter known as East 85th Street.



That Ward Drive in Terrace Park, be changed and hereafter known as East 86th Street.

That Haffner Drive in Terrace Park, be changed and hereafter known as East 87th Street.

That Mansfield Avenue in Monticello and Villa Hill, be changed and hereafter known as East 87th Street.

That Brainerd Avenue in Monticello, be changed and hereafter known as East 88th Street.

That Sheridan Avenue in Monticello, be changed and hereafter known as East 89th Street.

That Brainerd Avenue in Villa Hill, be changed and hereafter known as East 89th Street.

That Lincoln Avenue in Mabelville, Monticello and Villa Hill, be changed and hereafter known as East 90th Street.

That Lewis Avenue in Mabelville, be changed and hereafter known as East 91st Street.

That an unnamed street bounded on the west by blocks 14, 13, 12, 11, 10, 9, and 8, Mabelville and on the east by north and south quarter line through center of section 33, T.1 N.R.2 E.7.M be hereafter known as East 92nd Street.

That an unnamed street lying east of and adjacent to South Fairlawn, Fairlawn and North Fairlawn, be hereafter known as East 84th Street.

That an unnamed Street lying east of and adjacent to Sunrise Park be hereafter known as East 84th Street.

That an unnamed street lying west of and adjacent to St. Thomas, be hereafter known as East 84th Street.

That West Street in Supplementary Plat of Mansfield, be changed and hereafter known as East 84th Street.

That Ladner Street in Supplementary Plat of Mansfield, be changed and hereafter known as East 85th Street.

That Theron Street in Supplementary Plat of Mansfield and in Stanley, be changed and hereafter known as East 86th Street.

That Lewis Street in St. Thomas, be changed and hereafter known as East 86th Street.

That Thorburn Street in Stanley and Stanley No. 2 be changed and hereafter known as East 87th Street.

That Stanley Street in Stanley No. 2 be changed and hereafter known as East 88th Street.

That Tennant Street in Stanley No. 2 be changed and hereafter known as East 89th Street.

That Eastman Street in Railway Addition and Ryder's Addition be changed and hereafter known as East 84th Street.

That Theron Street in Railway Addition, be changed and hereafter known as East 86th Street.

That Braze Street in Railway Addition be changed and hereafter known as Russell Street.

That Sacramento Street in Railway Addition be changed and hereafter known as Braze Street.

That Thompson Street in Railway Addition be changed and hereafter known as Sacramento Street.

That East 62nd St. S. E. in Hermosa Park, be changed and hereafter be known as 61st Street South East.

That Admiral Street in Atlas Addition between a northerly extension of the west line of block 5 and a southerly extension of the east line of block 1, be changed and hereafter known as 49th Avenue South East.

That Douglas Avenue in Jose, be changed and hereafter known as 46th Avenue South East.

That East 41st Street in Laurelhurst from Mulmoad Street to Halsey Street, be changed and hereafter known as East 42nd Street.



That East 42nd Street in Laurelhurst, from East Burnside Street to Laurelhurst Avenue, be changed and hereafter known as East 43rd Street.

That East 43rd Street in Laurelhurst, from East Stark Street to Halsey Street, be changed and hereafter known as East 44th Street.

That East 45th Street in Maple Hill Place be changed and hereafter known as East 44th Street.

That Aloha Avenue in Iona S. Bickerton's Addition be changed and hereafter known as East 26th Street.

That East 29th Street in Seldon Place, Van's Addition and Harrison Hill, from Division Street to East Harrison Street, be changed and hereafter known as Kesilworth Avenue.

That East Road from Sandy Road to east line of East 60th Street as laid out in Summit Addition be changed and hereafter known as Halsey Street.

That Sandy Road from East 28th Street to the east boundary of the City of Portland shall be hereafter known as Sandy Boulevard.

That East 63rd Street in Parkhurst Addition from Pacific Street to Hassalo Street be changed and hereafter known as East 64th Street.

That 45th Street in Belgrade be changed and hereafter known as East 44th Street.

That 45th Street in Laurelbrest be changed and hereafter known as East 44th Street.

That 46th Street in Laurelforest and Belgrade be changed and hereafter known as East 45th Street.

That 47th Street in Laurelforest be changed and hereafter known as East 47th Street.

That East 46th Street in Maple Hill Place be changed and hereafter known as East 45th Street.

That East 41st Street in Laurelhurst from Hassalo Street to Multnomah Street be changed and hereafter known as Multnomah Street.

That Ellsworth Street in Josephine be changed and hereafter known as 29th Avenue South East.

That Tibbette Street in Josephine be changed and hereafter known as 31st Avenue South East.

That Franklin Street in Josephine be changed and hereafter known as 33rd Avenue South East.

That East 51st Street in Josephine be changed and hereafter known as 71st Street south east

That East 72nd Street in Josephine be changed and hereafter known as 73rd Street south east.

That East 73rd Street in Josephine be changed and hereafter known as 74th Street south east.

That East 17th Street in Alwood and Miller's Addition from Ochoo Avenue to Alden Avenue be changed and hereafter known as East 16th Street.

That East 17th Street in Sellwood, Mosely Addition and Crystal Springs Addition from Ochoco Avenue to Lambert Avenue be changed and hereafter known as East 17th Street.

That East 21st Street in Sellwood, Mosely Addition and Crystal Springs Addition from Ochoco Avenue to Lambert Avenue be changed and hereafter known as East 19th Street.

That East 25rd Street in Sellwood, Moseley Addition and Crystal Springs Addition from Ochoco Avenue to Lambert Avenue be changed and hereafter known as East 21st Street.

Section 3: Nothing contained in this Ordinance shall in any way effect the validity of any proceedings now pending for the improvement, opening, laying-out or widening of any of the streets above mentioned or for the changing or establishing of grades thereon, but such proceedings shall continue and be completed as though the names of such streets had not been changed.
