I am a resident of northeast Portland, writing to urge that you approve the amendment to Code Chapter 2.08 - Election of Candidates. The proposed changes were developed by trusted officials - election administrators and attorneys - of both Multnomah County and the City of Portland, based on research and community input. You can have confidence that your yes vote will be in accordance with the will of Portland voters.

The ordinance before you is informed by research on election data in the growing number of jurisdictions using ranked choice voting. Ranked Choice Voting Resource Center provided advice in its development, based in their background as former election officials and experience with helping to implement RCV in other jurisdictions. Because I personally provided input about my perspective on RCV through the online survey conducted by city officials - and urged friends, neighbors, and family to do the same - I am also confident that where choices were practical, the proposal reflects the wishes of Portland residents.

Your approval of changes to the code will both satisfy the needs of our election officials to successfully conduct future elections, and will enact the will of your constituents, the people of the City of Portland, as expressed last November when Measure 26-228 was passed with approval of nearly 57% of voters.

As my representative, I urge you to to what is needed to ensure the success of the changes to elections and city government. In the near term, that means approval of recommended changes to the City Code Chapter 2.08. Longer term, that will mean providing robust funding of voter education, particularly in communities historically underrepresented in Portland City government. Investing now in voter education will provide for a healthier Portland of tomorrow as more if its citizens have a voice in local government.

Testimony on Implementing Ranked Choice Voting Agenda Item 293 Submitted by Debbie Kitchin, Portland resident

Thank you, Mayor Wheeler and Commissioners, for the opportunity to speak today about implementing ranked choice voting. I was honored to be appointed by this body and to have served as a member of the Portland Charter Review Commission. I am here today to support the amendments to the Portland City Elections Code. I want to commend the work and collaboration of the City and Multnomah County staff and the ranked choice voting system experts that developed this ordinance. It is in strong alignment with what the Charter Commission intended and what voters approved. I urge you to vote yes to approve.

I think it is very important to note that it was the Charter Commission's intention to leave some of the policy details regarding elections up to code, to be adopted by city council, rather than putting them in the Charter. The City charter serves as the City's constitution, so it is at a very high level. It is not appropriate or prudent to put everything about city operations and policies in the charter. That would create an operating system that would be too rigid and not adaptable to changing conditions since any change to the charter must be approved by voters. The other places that policies and rules for city operations are expressed are in code and in administrative rules.

As a commission, we received extensive briefings from City attorneys and experts on what belongs in a charter and what types of details would be more appropriately represented in code. In addition, at many steps in the process, we discussed as a commission how to achieve our desired outcomes within the charter, understanding that some elements would be achieved through code. It came up often and on a number of issues and was an ongoing question for discussion. The election processes that are described in the ordinance before you are appropriately defined in code. This was the Charter commission's expectation and intention and was the result of careful deliberation. Again, I believe the ordinance before you is in strong alignment with what the Charter Amendments called for.

I would also like to say a few words in support of ranked choice voting. One of the Commission's desired outcomes was to have a participatory and growing democracy with more voices being heard in elections. Ranked choice voting allows voters to fully express their preferences without fear that their vote "won't count" because their first choice is not as

likely to win. Many voters are discouraged by the current system and do not feel motivated to vote. Feeling that their vote and preferences don't matter can lead to cynicism and lack of participation. Increasing participation helps our communities because people are more invested in the community when they feel their vote matters. Ranked choice voting can allow people to express their full preferences. Thank you for the opportunity to speak.

For the last few years, we have engaged with the charter review process very closely, and helped support the passage of Measure 26-228. We respectfully urge the City to move forward with adopting the Portland City Elections Code as it is presented to the Council.

Administering these changes now is essential for ensuring that our election officials have the framework they need to move forward to successfully implementing ranked choice voting elections on time for the November 2024 election. The elections code sets policy decisions that the Charter Review Commission purposefully and correctly left out of the charter, to allow for our county elections administrators, city auditor's office, and lawyers to finalize details according to best practice and voter experience.
