Dear Mayor Wheeler and Members of Council,

The Port of Portland (Port) is pleased to offer support for Advance Portland: A Call to Action for Inclusive Economic Growth. We recognize the enormous challenges facing our city, and the critical role Portland plays in Oregon's economic health. By prioritizing inclusive economic growth and climate action - this strategy sets the right tone for our times.

Advance Portland recognizes the interconnected nature of economic development, racial equity, transportation, and land use, thus compelling policymakers to think more holistically and balance sometimes conflicting priorities. Notably, the strategy speaks to Portland's business climate and opportunities for balanced leadership on topics ranging from land use and permitting to taxation. Implemented well, this strategy will foster better outcomes across the many services the City of Portland provides – building and improving public trust.

The Port's mission is to build shared prosperity through trade, travel, and economic development. We leverage our resources to connect people and businesses to economic opportunity - especially those who have been left out of the region's economic growth. We see deep alignment between our work and the objectives of the Advance Portland strategy and view our successes as mutually reliant.

The most obvious areas of programmatic intersection for the Port are across *Objective 1: Propel Inclusive Economic Growth and Innovation; Objective 2: Promote Equitable Wealth Creation;* and *Objective 4: Connect Portlanders to High Quality Jobs in Future Ready Sectors.* To highlight a few specific areas of coordination across these objectives:

## Terminal 2 Housing Innovation Campus – aligned with Objectives

The Port is invested in advancing traded sector cluster industries with key focus areas in mass timber, climate tech, semiconductors, and other sources of advanced manufacturing. Central to our work is the transformation of Terminal 2 (T2) into a Housing Innovation Campus. When complete, the campus will host housing manufacturing facilities, mass timber research and development, and incubator space for small scale companies focused on housing innovation.

This project seeks to boost demand for mass timber and prepare workers from all communities to fill the high-quality jobs needed in this emerging industry. A Regional Training Cluster is in development through partnership with Portland Community College and Worksystems, Inc. The strategy will establish training locations around the state that connect rural and urban communities to job opportunities in forestry, fabrication, construction, and manufacturing.

## **Climate Tech Innovation**

The Port is leveraging its real estate assets to identify, from a balanced portfolio approach, opportunities for scaling business growth. In support of BIPOC entrepreneurs in climate tech industries, the Port is a founding partner in the NW Xcelerator, recent winner of two Department of Energy EPIC prizes. These initiatives reflect opportunities to align with Prosper Portland's technical support programs.

## Investments in East Multnomah County

We see potential for significant quality job growth in east Multnomah County, as well as opportunities to support local business. East Multnomah County is uniquely positioned for equitable growth but needs a coordinated strategy to identify and obtain necessary, sustained support. The Port is committed to leveraging our strengths – properties, relationships, and expertise – toward a more equitable and prosperous future for this part of the region.

More broadly, *Objective 3: Foster a Vibrant Central City and Commercial Districts* is of critical and timely importance. Portland's beloved common spaces need to be energized, busy, safe, and inclusive. In addition, we appreciate the focus on industrial land and international trade as issues critical to Portland's future; and where the Port will continue to bring expertise and leadership.

We commend Prosper Portland for leading the charge on this strategy and engaging so many community, business, and intergovernmental leaders along the way. The Port is fully committed to ongoing partnership in further planning and implementation. Together, we will continue to demonstrate that a healthy economy is both equitable and competitive – and that Portland's best days are to come.
