An Ordinance authorizing the Mayor and Auditor to receive a
deed from D.E.Keasey to two certain parcels of land on
Portland Heights for the Water Department of the City
of Portland.

THE CITY OF PORTLAND DOES ORDAIN AS FOLLOWS:

Section 1. That the Mayor and Auditor of the City of
Portland by and they are hereby authorized to receive a deed
from D.E.Keasey to the following described parcels of real
property in the City of Portland, Multnomah County, Oregon,
to wit:

Beginning at a point in the west side line of Greenway
S. 0° 13' W. 38.29 feet distant from the northwest corner of
Lot 6, Block K, Greenway, as platted and recorded in Book 360,
Page 10, Record of Multnomah County; thence following the
southeasterly boundary of a certain 30 foot right of way, par-
allel with and 15 feet distant from the center line of said
right of way, on a course deflecting 59° 52' to the right from
a southerly extension of the west side line of Greenway, a dis-
tance of 33 feet to a point; thence on a curve to the left,
having a radius of 176.07 feet, and consuming an angle of 34°
54', a distance of 107.17 feet to a point; thence tangent to
the curve, a distance of 7.2 feet to a point; thence easterly
106.12 feet to a point in the west side line of Greenway;
thence north 0° 13' E. along the said west line of Greenway,
a distance of 104.86 feet to the place of beginning, contain-

ing 6970 square feet more or less;

Also all of Lots six (6) and seven (7) lying south and southeasterly of the right of way of the Portland Railway Company, and that part of Lot five (5) lying southeasterly of the right of way of the Portland Railway Company and lying westerly of the east line of said Lot seven (7) if extended, all in Block "K", Greenway, according to the plat of Blocks "J" to "P", Greenway, on record in the office of the County Clerk of said county.

Section 2. That said deed of conveyance from D.E.Keasey to the above described parcels of land is taken by the City of Portland and the said property is accepted in lieu of payment by said D.E.Keasey of the sum of \$4000 due the City of Portland from and which sum was bid by said Keasey for Block 235 in the City of Portland and a parcel of land described as follows: Commencing at a point in the west boundary line of Ravensview in the City of Portland, County of Multnomah, State of Oregon, which point is 59.4 feet west and 898 feet north of the section corners between Sections 4,5,8 and 9, Township 1 South, Range 1 East of the Willamette Meridian, running thence easterly at right angles to the west boundary line of Ravensview 50 feet; thence southerly parallel to the west boundary line of Ravensview 50 feet; thence westerly at right angles to the last named line 50 feet to the west boundary line of Ravensview; thence northerly along the west boundary line of Ravensview 50 feet to the place of beginning; the sale of which parcels was heretofore directed to be made to the highest bidder by the Executive Board, and the same having been sold to said D.E.Keasey as the highest bidder therefor for the said sum of \$4000.
