MINUTE - FEBRUARY 6, 1974

Meeting of the Portland Municipal Boxing and Wrestling Commission was called to order by Chairman Nick Sckavone on February 6, 1974 at 7:30 P. M. in the Woodmen Building, 1847 S. E. Clinton, Portland, Oregon. Members of the Commission present were Don Casciato, Ken Wilhelmi and Jack Battalia along with Bob Cosby, Ted Kincaid, Sam Singer, Harvey Isaacs, Benny La Ford and George Yerkovich.

Minutes of the previous meeting were read and approved as read on a motion by Dr. Ken Wilhelmi and seconded by Don Casciato.

The receipts and disbursements for the months of November, December, 1973 and January 1974 were read and accepted with a motion by Don Casciato and seconded by Dr. Jack Battalia.

The following fight card was presented by the Three Star Sports for sanctioning on Feb. 14th. The card to take place at the PI.

Ken Wilhelmi made a motion that the program be sanctioned as presented. Seconded by Jack Battalia. Motion carried.

A letter from Sandy Barr was read in which he requested a matchmakers license for promoting boxing matches. The commission requested the secretary to write Mr. Barr a letter and refer him to the qualifications requested in the rule book. Mr. Barr was also to be notified to be present at the next commission meeting for final ruling.

Nick Sckavone told of the mayor receiving a letter from a wrestling fan in regards to some tactics of a certain wrestler. He also read the letter in which he answered this fan. He also told of the debate between Mr. Thomas and Don Owens in regards to amateur and professional wrestling.

The chairman reported about receiving calls concerning the Jekyl and Hyde Restaurant putting on wrestling matches at their establishment. He was also using some of the professional wrestlers names in his advertising. He had called the manager of the restaurant and was informed that he would still put on wrestling regardless of the commission. In response to a request from Don Owens, the secretary had called Bob Cosby of the police bureau to check this out and see what they were doing.

Bob Cosby reported that he had gone down and discovered that the wrestlers were dressing down in the area where the customers were eating and also walking around stripped to the waist and without shoes. He also stated that he had overheard that each wrestler was being paid \$25.00 and a cover charge of \$1.00 made.

Nick Sckavone stated that he had called the manager to appear before the commission at this meeting which they had undoubtedly declined to do. Ted Kincaid of the Oregon Liquor Commission said he would talk to these gentlemen about this situation and report back to the commission. George Yerkovich was asked to get a legal opinion as to the commissions stand on this matter. Various discussions followed and also a copy of the state statute was read. Nick thanked Ten Kincaid for appearing before the commission.

It was announced that George Yerkovich and Dr. Jack Battalia would be going to Lake Tahoe for an executive meeting of the N. A. B. F. representing the commission. He told of poling the commission and all had been in agreement for these two gentlemen to go. The secretary asked George Yerkovich to get information in regards to what size gloves they use for heavy weight bouts in professional fights in California and Nevada.

Harvey Isaacs asked what progress had been made in regards to a pro-am card. Various discussions followed on this matter.

A motion was made by Ken Wilhelmi to purchase the necessary number of Ring Books. Seconded by Don Casciato. Motion carried.

Don Casciato inquired at to whether Tex Hager was planning another event. Nick stated that he was supposed to have a card on March 28, 1974.

There being no further business the meeting was adjourned.

MINUTES - APRIL 10, 1974

Meeting of the Portland Municipal Boxing and Wrestling Commission was called to order by Chairman, Nick Sckavone, on April 10, 1974, at 7:00 P. M. in the Woodmen Building, 1847 S. E. Clinton, Portland, Oregon. Those present were Nick Sckavone, Don Casciato, Dr. Ken. Wilhelmi, Bob Cosby, Abe Tansman, Paul Weitzel, Harvey Isaacs, Sam Singer, Robert Gaughran and Lee Ramses.

Minutes of the previous meeting were read and approved on a motion by Dr. Wilhelmi and seconded by Don Casciato. The receipts and disbursements for the month of February were read and accepted on a motion made by Don Casciato and seconded by Ken Wilhemi.

The chairman reported that the attorney for the Jekyl and Hyde Restaurant was to have appeared before the commission at this time but since two of the members were not going to be present, he had asked the secretary to inform him of this fact. The attorney had agreed that it would be best to be present when there was a full commission present.

The chairman had also requested the secretary to contact Mr. Hager and inform him that his request for a date for a fight card should be in writing. Mr. Hager had complied with this request and was asking for the date of May 16, 1974. It was further explained that Tex Hager had asked for the date of April 4th but the chairman told him that this was too near the time scheduled for a fight by Three Star Enterprises. A further discussion followed as to whether dates in the past had been switched two or three times for Sam Singer. Nick went on to explain that at the time Mr. Hager had no definite date in mind and Sam Singer had fighters available for that month so the commission granted those dates to Sam. Dr. Ken Wilhelmi made a motion that we grant the date of May 16, 1974, for a fight card for Tex Hager. Seconded by Don Casciato. Motion carried.

Before asking the two attorneys representing Sandy Barr in the matter of obtaining a promoters license to promote boxing in the City of Portland, to present their case, it was pointed out that since two of the commissioners were not present, it was suggested that they bring their full presentation back at the next meeting. Nick Sckavone went on to point out some of the discussion he had had with Sandy Barr in regards to the pitfalls in the boxing game and also if the attorneys present had any questions, those members of the board present would try to answer them. The attorneys asked if the performance bond

could be carried over each week and was informed that it would require a \$52,000.00 bond if weekly events were to be put on. \$1,000.00 could be withdrawn after the conclusion of each weekly match. The attorney stated that he would try to work this out with the insurance company as to how they could handle this situation. He further stated that the commission would receive a letter around the end of April in regards to the insurance and as to how the bonding and insurance company would work with them.
