# City Council to consider amendments to Better Housing by Design on November 6 at 2 p.m.

A list of potential amendments to the Better Housing by Design Recommended Draft is now available for review.

Portland City Council will consider and vote on amendments to the Recommended Draft on Wednesday November 6, 2019, following a continuation of the public hearing on the Better Housing by Design Recommended Draft, which is scheduled to start at 2 p.m.

The draft amendments were requested by City Commissioners and are subject to change before being considered by City Council on November 6. That's because commissioners will continue to consider public testimony until the public hearing closes that same day.

The potential BHD amendments include the following:

- Amendments to the Deeper Housing Affordability Bonus to provide options for affordable ownership housing.
- Expanded exemptions from minimum parking requirements for projects providing affordable housing.
- Limitations on using development bonuses on sites where historic buildings have been demolished in the multi-dwelling and mixed-use zones.
- Prohibitions on using development bonuses on sites more than a 1,500-foot walking distance of frequent-service transit.
- Disallowing 100-foot building height in the RM4 zone in historic districts.
- Requirements for large sites to include indoor common areas, such as community or recreation rooms.
- Changes to the zoning of specific historic properties to support their preservation.
- Zone changes in the King's Hill Historic District to reduce allowed building scale.

• A series of minor code amendments, including allowances for triplexes and fourplexes on small lots.

You can testify on these draft amendments and on the Recommended Draft using the Map App or during the November 6 public hearing. Community members who signed up to testify for the October 2 public hearing (but were not able to testify before the hearing closed) will be given priority to testify early on November 6.

Anyone else who would like to provide testimony on the Better Housing by Design Recommended Draft or the draft amendments is also welcome to testify during the November 6 public hearing.

Written testimony will continue to be accepted through 2 p.m. on November 6, 2019. Please see below for information on how to submit testimony.
