He came to NAYA in 2016 after being the Executive Director of the Columbia River Inter-Tribal Fish Commission (CRITFC) since 2009. Prior to that Paul served as Executive Director of the National American Indian Housing Council in Washington DC from 2007 to 2009. While also in DC, Paul served as the Senior Tribal Liaison for the U.S. Department of Defense from 2004-2007. From 1987 to 2004, Paul served in several capacities at CRITFC.

Paul has a wide-ranging background on issues impacting American Indians, Alaska Natives, and Native Hawaiians. Mr. Lumley has worked directly with tribal governments, tribal consortia, virtually all federal agencies impacting Indian country, and Native American national and regional organizations throughout his professional career. Experience areas include tribal treaty rights, environmental protection and restoration, housing, defense, education and social services. Paul earned a Bachelor of Science in Mathematics from Western Washington University in 1986. This July, Paul will step down from his position at NAYA to begin a new chapter as the CEO for the [Cascade AIDS Project](#).
