The City of Portland's Bureau of Planning & Sustainability is accepting applications through May 6, 2011, for three community members to serve on the Community Involvement Committee (CIC) for the Portland Plan and the Comprehensive Plan Update.

The **Portland Plan** provides an opportunity for Portlanders to help define priorities, guide investments and set the course for the city for the next 25 years. It is a multi-year, citywide project to create a strategic plan, with short-term actions and a long-range plan, to guide the physical, economic, social, cultural and environmental development. Eighteen partners from local government and public agencies have joined in this effort.

The **Comprehensive Plan** will provide a coordinated set of guidelines for decision-making for the future growth and development of the city, as well as implementation measures to accomplish the desired results. The Comprehensive Plan will provide the City with:

- A set of Land Use and Public Facilities Goals and Policies to guide the development and redevelopment of the city.
- A Comprehensive Plan Map and a set of regulations for development, including a revised Zoning Code, to carry out the policies.
- A guide for the major public investments required to implement the plan.
- A process for review and amendment of the plan.

Community Involvement Committee Charge

The charge of the CIC is to review and make recommendations on the public involvement efforts for the Portland Plan and the Comprehensive Plan Update. The committee reviews past involvement efforts and results and preview upcoming involvement activities. The committee makes recommendations to the Planning & Sustainability Commission (PSC) and staff on ways to continue or improve its public involvement activities so they meet the overall goals of the public involvement work program.

The CIC comprises of up to three Planning & Sustainability Commissioners and 15 members of the community at large. CIC members should expect to meet monthly at Wednesday morning meetings. Quarterly, there are Wednesday evening meetings held instead.

Member Qualifications and Skills

Portlanders who are interested in serving on the CIC should have the following:

- Strong interest in and understanding of public involvement processes.
- Commitment to the City's goal for the CIC: To oversee and strengthen the community's involvement and capacity to participate with the Bureau of Planning & Sustainability, partner bureaus and government agencies in the development of the Portland Plan and Comprehensive Plan Update.
- Ability to work collaboratively with people of diverse perspectives and experiences.
- Willingness to contribute to successful group work; team player.
- Ability to commit 2-3 hours every month, plus preparation for monthly meetings; additional subcommittee meetings; public involvement events; presenting at Planning & Sustainability Commission, City Council, etc.
- Live, work and/or go to school in the City of Portland.

Member Responsibilities

- Review public involvement methods, activities and results. Approximate end date for the Portland Plan is December 2011 and Comprehensive Plan Update is December 2012.
- Review and make recommendations for involvement methods and activities for the coming month.
- Consider issues and concerns from a citywide perspective.

Selection Process

Applications will be reviewed by a selection committee consisting of members of the Portland Plan Community Involvement Committee; Bureau of Planning & Sustainability staff; and Office of the Mayor staff. Final consideration and appointments will be made by the Mayor and approved by City Council in June 2011. This application is to fill three vacant positions on the CIC.
