The evolution of PCEF's program structure

Identify changes to enable accelerated funding of carbon reduction projects in alignment with ballot measure 26-201.

Goal #2:

Draw clearer and more relevant connections between PCEF and the City's carbon reduction goals.

Address administrative and operational needs identified by staff and committee.

Address remaining audit recommendations.

#1 - Develop 5-Year Climate Investment Plan

Climate Investment Plan (CIP): A strategic framework for PCEF investments

- Replaces current funding allocations in city code.
- Recommended by the PCEF Committee, approved by the Portland City Council.
- Development process includes community input and public comment.
- CIP must also specifically address:
 - Continued funding allocations for community responsive grants program;
 - New strategic programs; and
 - Measurable goals and/or outcomes for each program.
- CIP updated every 5 years, with opportunity for evaluation and responsive adjustment.
- Initial CIP must be created within 9 months with subsequent CIPs to be updated no later than 6 months after the expiration of the former CIP.

#2 - Initial strategic programs and funding priorities

Initial programs to be developed and launched immediately:

- Strategic program #1: Growing an equitable tree canopy (and workforce and contracting pool) to support the City's 2035 tree canopy cover goals \$40 million.
- Strategic program #2: Raising the bar on efficiency and renewable energy upgrades in new and redeveloped regulated affordable multifamily housing \$60 million.

Funding priorities and strategic programs:

- Transportation decarbonization: \$100 million
- Low-cost access to capital for carbon reducing projects:
 \$100 million
- Resilient community centers: \$30 million
- Building community-based organization operational capacity: \$8 million
- 82nd Ave planning and early investment for low carbon equitable communities: \$10 million

^{*}The allocations above are inclusive of workforce development and contractor support programming and funding distributed through the community responsive grants program.

S.	Clean up internal inconsistencies in definitions
t.	Expand Committee member eligibility so that Committee members can live, work, or have other demonstrated involvement within City boundaries

PCEF

Modified consensus decision making process

- **Proposal** put forth for consideration by Committee member
- **Temperature check** each Committee member indicates how comfortable they are with making an affirmative decision
- Discussion additional discussion if needed
- Amendments Committee members can offer amendments to the original proposal
- **Decision** each Committee member can 1) affirm the proposal, 2) stand aside, or 3) indicate that "no" they do not support the proposal. Note that standing aside is counted as a decision to affirm for the purposes of approving a proposal.

The following minimum number of affirmative decisions is required for a decision to represent the position of the PCEF Committee.

- When 6 or 7 Committee members are present : 5 Affirmative decisions
- When 8 or 9 Committee members are present : 6 Affirmative decisions
