

Interim Director's Update – September 2023

General Updates

- IH Calibration Study is near completion. Remaining work includes scenario analysis for potential tax exemption expansion outside the Central City and the final report from consultant. - Council adopted a new cap for maximum number of annual applications for the Homebuyer Opportunity
 Limited Tax Exemption (HOLTE) program. For the next three years the application cap will be 500, up
 from 100 annually. The city will analyze the program for effectiveness in boosting production of familysized middle housing and expanding access to homeownership for communities of color.
- PHB and Prosper Portland are leading a tax increment finance (TIF) district exploration process for East Portland and 82nd Avenue. Process will include public engagement conducted by community based organizations and city staff as well as focused conversations by Working Groups to recommend district boundaries and to co-create plans for the new districts if there is sufficient interest and support.
