COLD ASSAULT

Flagged down at NW 9th Ave / NW Flanders St regarding a cold assault call that had occurred on 04/24/22 approximately 30 minutes ago.

I spoke to the victim, Jason Wilder who stated that he was in a verbal argument with an unknown male suspect near NW 3rd Ave / NW Burnside St. He stated that the male approached him and struck him in the face. Jason stated that following the suspect's strike, they both engaged in a "scuffle" consisting of numerous punches / strikes. Jason mentioned that the male left the location in an unknown direction. Jason described the suspect as a white male with red hair, in all black clothing, and had a "Scottish accent".

Jason had a minor injury to his nose but did not request medical attention. Jason did not request to pursue charges at this time. I agreed to area check for the male but was UTL.

05/03/22

- I received a phone call on my Bureau-issued cell phone from a blocked phone number. I briefly spoke with Jason Wilder who was contacting me regarding the status of the police report for the mentioned case number. I advised Jason that a police report had not been filed at this point, and I notified him that I would attempt to call him back following a protest detail that I was currently assigned to. I attempted to call the phone number back that he gave me on 04/24/22 on multiple occasions following the detail. I received an answer during the second phone call, however I was advised that the phone number did not belong to Jason.
- I intend to follow-up with Jason in the near future (in person) regarding the assault that occurred on 04/24/22.
