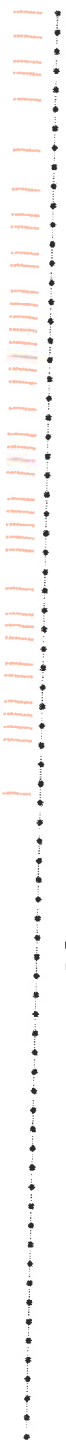

How can I participate?

2. **Testify at the City Council hearing.** The hearing on August 30 at 2:00 p.m. will be a hybrid format with options to participate in-person or virtually using a computer, mobile device or telephone. Capacity is limited for in-person testimony; providing virtual testimony is recommended at this time. You **must** sign up to testify in advance. The Council Clerk will post the agenda with the public testimony registration links on Friday, August 25 at 9:00 am. To testify before City Council in person or virtually:
