SPECIAL REPORTS & PROJECT UPDATES: PROPOSED SMOKE FREE PORTLAND PARKS POLICY

- 1. Letter to the Commissioner provided to the committee
- 2. Meeting with Commissioner Fritz and Vicki and Bill last week
 - a. Commissioner Fritz not in favor of phase in plan, plan to begin policy on July 1, 2015
 - b. Permit process will be created to request exception for tournaments and group events
 i. No permit fee will be required
 - c. Parks or Operator staff will not be required to enforce or patrol
 - d. No sanctions or fines will be in the policy or ordinance
 - e. Ordinance will require a public hearing where opinions can be heard
 - f. Option for designated smoking area for employees
 - g. Willing to hear back from committee after six months of implementation if unforeseen impacts place hardship on the fund
- 3. Concerns raised over Ordinance versus Resolution by committee
 - a. Ordinance required to amend code and to have a public hearing
- 4. Concerns over dynamic between smokers and nonsmokers
 - a. Complaints to the pro shop/marshals becoming customer service issue, how should operators respond?
 - b. Request for clear direction
- 5. Committee would like to advise on the permitting process for tournament and group play

WINTER PLAY COURSE CONDITIONS

- 1. Concern over conditions of turf and loss of play to other courses
 - a. Unusual weather pattern creates 'mushy' surface.
 - i. Freezing of ground and then heavy rain difficult to manage
 - ii. Other courses with heavy usage will experience similar issues
 - b. Worm casings on course
 - i. City follows Integrated Pest Management (IPM) program
 - ii. No approved pesticides for worms
- 2. Institute Superintendent report to create awareness and education surrounding course conditions.

HIGH SCHOOL GOLF PROGRAM - STORAGE OF CLUBS

- 1. Asking for locker storage at home golf courses for High School Golf Clubs
 - a. Difficulty for students to get equipment to and from school
- 2. Promise to look into solutions lockers are available for use ask each course for specifics
