## Re: Briefing – Johnson-Kearney Belgian Block Deployment Request December 11, 2023

# INTRODUCTION

# **BELGIAN BLOCKS CONTEXT**

Belgian Blocks made of basalt were used as a primary paving surface in the City of Portland during the late 1800s and early 1900s. Over time, asphalt replaced Belgian Blocks as the primary road surface, often being applied directly over the blocks. During street repair projects, Belgian Blocks are often rediscovered. In the 1970s, City Council passed ordinances (139670 and 141548) to plan for the recovery, storage, and redeployment of Belgian Blocks. Since 1975, the Historic Landmarks Commission has been responsible for reviewing and approving deployment requests.

### **DEPLOYMENT REVIEW PROCESS**

The Historic Landmarks Commission adopted criteria for the deployment of Belgian Blocks in 1975. Those criteria remain in effect today and are copied below:

- 1. Cobblestones should be reused primarily in districts or areas of the City where they were originally used. Historic Districts and Historic Landmarks where cobblestones were originally used as the paving material should receive first priority.
- 2. As a general policy, cobblestones should be used for large paving areas, primarily in public pedestrian spaces where the special character of cobblestone texture would be meaningful. The use of cobblestones as small decorative elements in unrelated or isolated projects should be discouraged, as these uses are usually insignificant or inappropriate.

#### ADDITIONAL INFORMATION

In 2021, the Bureau of Planning and Sustainability commissioned a study on Belgian Blocks to better detail the opportunities for and constraints of deploying the blocks in a manner consistent with the Americans with Disabilities Act (ADA).
