SECTION 4 FIRST AID MEASURES

Description of first aid measures

Eye: Flush eyes with water immediately while holding the eyelids open. Remove contact lenses, if worn, after initial flushing, and continue flushing for at least 15 minutes. SECTION 6 ACCIDENTAL RELEASE MEASURES

ADDITIONAL TOXICOLOGY INFORMATION:

This product contains diethylene glycol (DEG). The estimated oral lethal dose is about 50 cc (1.6 oz) for an adult human. DEG has caused the following effects in laboratory animals: liver abnormalities, kidney damage and blood abnormalities. It has been suggested as a cause of the following effects in humans: liver abnormalities, kidney damage, lung damage and central nervous system damage.

This product contains 2-butoxyethanol (2-BE, CAS# 111-76-2). 2-BE is not considered a significant acute or chronic toxicity hazard in humans. A validated physiologically based pharmacokinetic model indicates that humans receiving extensive dermal or inhalation exposure to 2-BE would not receive a toxic dose of 2-butoxyacetic acid (Appl. Occup. Environ. Hyg. 8:580-586, 1993), the metabolite principally responsible for the observed toxicity of 2-BE in laboratory animals. This product contains petroleum base oils which may be refined by various processes including severe solvent extraction, severe hydrocracking, or severe hydrotreating. None of the oils requires a cancer warning under the OSHA Hazard Communication Standard (29 CFR 1910.1200). These oils have not been listed in the National Toxicology Program (NTP) Annual Report nor have they been classified by the International Agency for Research on Cancer (IARC) as; carcinogenic to humans (Group 1), probably carcinogenic to humans (Group 2B).
