Site is a level, inside, partially landscaped 50'x100' lot with lawn and flat concrete work. The lot is approximately 3 feet above street grade. All public utilities are connected.

Improvements consist of 2 older 2-story duplexes built in 1904 and each containing 725 sq. ft. of main floor area.

This duplex consists of up and down apartments with the owner living upstairs and Joe Brown in the lower apartment, rent free, for looking after the property. The main floor apartment has a living room, bedroom, kitchen and old style bath. The original dining room has been converted into a bedroom.

The upper apartment has a living room, kitchenette, bedroom and old style bath. The interior is of lath and plaster, fir and linoleum floors. There is a full concrete basement with fuel furnace, gas water heater, and single basement garage. This unit is in fair condition. The exterior is of asbestos shakes, fir trim and composition roof. Exterior needs paint.
