

Dear Mr. Romano:

This is in response to your letter of June 3, 1987, regarding City Ordinance No. 159639, which the Council adopted on May 7. That ordinance codifies the City's personnel policies and procedures, including clauses which prohibit discrimination in the City's employment practices. It was available for public review prior to its consideration by Council, as are all City ordinances. The City Council passed this ordinance in public session, with the public having the opportunity to testify.

It is my duty as Mayor to provide the citizens of Portland with the best government services at the lowest cost. In order to fulfill my responsibilities, it is essential that I do everything possible to hire the most qualified people. These people must be judged on their ability to do the job for which they are hired. Discrimination based on factors unrelated to job performance is not only reprehensible, it does a disservice to the taxpayers. It has furthermore been the City's policy since 1974 not to discriminate in its employment practices because of an individual's sexual preference.

In sum, the ordinance in question is a reaffirmation of a policy that has been in effect for 13 years; it was submitted and adopted openly; and it is in the best interests of the citizens of Portland. I supported the ordinance when it was before the Council, and I continue to support it. I will not take any action to reconsider it, nor would I support any such action if another member of Council introduced it. I consider this matter closed.



Dear Mayor Clark:

I am writing regarding HB 2325. I understand that you support this legislation and "homosexual rights".



- 3. The vague wording of section 3 could eventually force churches to hire homosexuals who shared other tenets held by that church, even if the applicant violated the Bible's injunction against a homosexual lifestyle.
- 4. To separate this issue from the issue of AIDS is intellectual suicide. Our public health officials and the news media have been trying to do so and the result is an increase of this disease in the heterosexual population. Studies have indicated the presence of the virus in all bodily emissions (Dr. Richard Restak, Washington neurologist) Studies have also indicated that this virus can easily mutate. Instead of protecting my family and others from "the steaming locomotive roaring down the tracks at the general population" (Mr. Mel Rosen, Gay Men's Health Crisis, New York City, 1983), this piece of legislation would place us in greater danger.



I feel you and others who support this legislation are selling us ordinary citzens "down the river".

In light of the above information (and much more not included here), should this bill pass, my family will "vote with our feet" by discontinuing our visits to eating establishments and removing our children from public schools.

We are currently informing everyone we know about HB 2535.
