# An open letter to the gay community on hepatitis B

Hepatitis B, a serious disease, The hepatitis B virus can be may be sexually transmitted Sexually transmitted diseases among the

gay community are epidemic. Herpes has recently received a lot of attention: gonorrhea and syphilis are well known; but the Centers for Disease Control (CDC) recently issued a major recommendation for the prevention of another sexually transmitted disease: Hepatitis B. In their Morbidity and Mortality Weekly Report, the CDC stated: "Susceptible homosexually active males should be vaccinated [against hepatitis B] regardless of their age or duration of their homosexual practices."

Gay men are at a high risk of contracting hepatitis B

In one study, from 51% to 76% of 3,816 gay men seen in five sexually transmitted disease clinics had evidence of past or present hepatitis B infection. Once infected, there's a 6% to 10% chance of becoming a carrier—capable of passing on the virus. The CDC estimated there are nearly 1 million carriers in the United States and that 100,000 of these carriers are gay men.

passed on by contact with contaminated body fluids

such as saliva, urine, semen, and blood. The hepatitis B virus can be transmitted through tiny breaks in the skin or contact with mucous membranes. This can occur during intimate sexual contact and can lead to hepatitis B for the partner of an infected person. Although most patients recover and over half contracting hepatitis B do not get symptoms, there is no specific treatment and no known cure for hepatitis B infections.

Hepatitis B may lead to even more serious complications

For those who do get symptoms of hepatitis B, a mild or severe "flu-like" sickness may continue for weeks or months. Ten percent of all infections become long lasting (chronic) with potential complications that are sometimes more serious than those of other sexually transmitted diseases. The carrier state, chronic active hepatitis, chronic persistent hepatitis, cirrhosis, and even cancer of the liver. Every year almost 4,000 carriers die of cirrhosis. In addition, carriers have a risk 273 times greater than that of the general population of contracting a usually fatal form of liver cancer.

Now this serious sexually transmitted disease is usually preventable by vaccination with the new hepatitis B vaccine

After more than a decade of research and development, a new vaccine is available for prevention, not treatment, of hepatitis B. In clinical studies, the vaccine was highly effective in preventing hepatitis B infection and was generally well tolerated. No serious adverse reactions occurred in these studies.

The vaccination regimen consists of a series of three injections, the first two a month apart and the third, six months after the first. To be effective, the vaccine must be given before a person gets hepatitis B. The vaccine helps prevent the disease: It is not effective as a treatment. We suggest that you consult your doctor to determine if you should be vaccinated.

Why you should consult your doctor or clinic

The vaccine helps protect against infection caused by hepatitis B virus. This virus is an important cause of viral hepatitis, a disease mainly of the liver. Even mild forms of this disease may lead to serious complications and aftereffects, including liver cancer. There is no specific treatment for viral hepatitis.

Vaccination is recommended for persons who have a higher risk of becoming infected with hepatitis B virus because of frequent, close contact with infected people or exposure to body fluids from such people. It will not

protect against hepatitis caused by viruses other than hepatitis B virus.

No serious adverse reactions were reported in over 6,000 individuals receiving the vaccine in clinical trials. The most frequent reaction was soreness at the point of injection; less common local reactions included redness, swelling, warmth, or formation of a hard, lumplike spot. The local effects were usually mild and lasted no more than 2 days after vaccination. Occasionally, low-grade fever (less than 101 °F) occurred. When it did, it usually lasted no longer than 48 hours following vaccination. In

rare cases, fever over 102 °F was reported.

More generalized complaints including malaise, fatigue, headache, nausea, dizziness, muscle pain, and joint pain were reported infrequently. Rash was reported rarely. As with any vaccine, broad use may reveal additional adverse reactions.

Your doctor or clinic knows what special care must be taken when administering the vaccine and in determining who should receive the vaccine. The vaccine is not intended for persons who are allergic to any of its

#### PHOENIX RISING GETS GRANT

Jerry Weller, Executive Director of Pdx. Oregon's Town Council Foundation (also known as Phoenix Rising) announced on Dec. 7, 1982 that the counseling programs of Phoenix Rising received a \$7,500.00 grant from Cascade Health Care, Inc. Cascade Health Care provided health programs in Portland until two years ago when it closed for financial reasons. Over the past two years the organization's board developed a plan to distribute the remainder of Cascade's resources. Phoenix Rising is the only lesbian/gay organization of the twelve foundations that received funds.

The funds from Cascade Health Care will be used to continue Phoenix Rising's one-to-one couseling programs as well as the specialized group counseling programs.

Phoenix Rising also offers a public education program aimed at educating non-gays about the needs and issues of the lesbian and gay community. A great emphasis is placed on educating civic and progessional organizations. Over forty lesbians and gay men have been trained as speakers for the program.

#### **Medical Technology** Can be use to detect your SEXUALITY

One of the methods used by anti-gay psychiatrists to invasively determine sexual orientation in conjunction with aversion treatments is the Electoencephalogram (EEG) This apparatus up to now had limitations. It had to be attached to the head with electrodes using conductive pastes and it primarily measured the electrical activity at the surface and near the surface areas of the brain. Recently as reported in Mc Graw Hill magazine

"Electronic", Nov. 1982, a new method of measurement of brain activity called the magnetoencephalogram (MEG) has been developed using Superconducting Quantum Inerference Devices (SQUIDS). This device can not only measure the electrical activity deep within the brain that was previously only accessible through surgical implantation of electrodes but it can also do it without physical contact with the subject. Additionally addition the device can characterize other parameters that the EEG could not measure.

Though primarily designed to aid epileptics, its interest to anti-gay psychiatrist is virtually assured. Every technical advance that measures any neurological function has been used by anti-Gay psychiatrists to detect homosexuals that might be trying to evade detection and to monitor the effects of aversion therapy, both drug shock and electroshock.

The equipment has been miniaturized from a cumbersome large apparatus often room size, to a small portable unit. Mechanical recording has been changed to digital readout suitable for computers. Formally the apparatus had to be strapped to the subject but now can be operated remote from the patient.

. Do no participate in any experiment in which a penile plethsymograph is attached to you. This is a device to measure the extent of an erection in the male. 2. If films, photos, or sounds of an erotic nature are shown, do not participate. Measurements of your heartbeat, pupillar response, or galvanic skin response could

be used to invasively detect Gays. 3. Investigate the researcher. Determine if any anti-Gay studies have been published. Your medical library, Gay student groups, or LGAES could provide information to

4. Notify your local Gay organizations, LGAES, and local Gay paper if any anti-Gay research is detected. 5. Discourage any straight friends from participating.

Straights are used as the control in the studies.

#### **EUGENE** Reaffirms Rights of GAY Employees

At the request of Right To Privacy Lobby the Eugene City Council reaffirmed the city's stand that no worker can be fired simply because he or she is gay. On Thur. Dec. 9, City Councilor Gretchen Miller made public at a regular session of the Council a city attotney's opinion regarding this policy which the Council passed in 1978 shortly after the city wide non discrimination law protecting gays was defeated in a referendum.

"We asked the city attorney for an opinion because this non-discrimination policy has gone almost unnoticed, 'stated Right to Privacy Lobby Chair Jerry Weller. Councilor Miller requested that an article regarding the policy be printed in the city employee's newsletter so that all employees are aware of their rights. She stated that she raised the issue "...to make it clear that people don't need to be afraid or closeted in fear." Eugene attorney and Lobby board member Dana Weinstein commented on the policy and made clear that it is very limited and protects only permanent city employees. "The coverage is quite narrow, "she stated "It does not even cover hiring procedures. It's an important step for Eugene citizens, but it is only a step. We will be going for a much broader policy statement soon."

Eugene Right To Privacy Lobby board member Terry Bean asked the Council to pass the non-discrimination policy in 1978 after the city wide ordinance was defeated. Bean was in Florida traveling for GRNL of which he is also a board member and was unavailable for comment.

The board is considering many gay issues other than just a full civil rights bill including prison reform and professional licensing procedures. Other board members include: Terry Bean, also a board member of Gay Rights National Lobby, Keeston Lowery, and John Baker.

#### **GLAD** hires director

Boston--Gay and Lesbian Advocates and Defenders (CLAD), New England's nonprofit public interest gay legal defense organization, today formally announced that Kathy Travers has joined GLAD as its first full-time paid Executive Director.

Kathy will coordinate GLAD's educational and community outreach programs (such as the wallet card "Your Rights--If You Are Arrested" recently published by GLAD) and GLAD's educational talks to community groups. Kathy will work with GLAD's Board of Directors to determine the direction of GLAD's growing litigation docket and to expand the network of cooperating attorneys handling GLAD's cases.

GLAD was founded in the fall of 1978 by a group of Boston activists in response to media and poli- National Educational tical attacks on the gay community. GLAD's objective is two-fold: to educate the lesbian and gay community and the public at large about the civil rights of gay people and to vindicate those rights in the courts.

GLAD's current docket include two new cases:

GLAD has agreed to assist the Boston newspaper FAG RAG in defending its right to receive gay journals rom other countries. Reently, copies of the

Swedish gay magazine Revolt addressed to FAG RAG were seized by U.S. Customs and are being held as obscene. Revolt combines gay male photos with serious coverage of gay liberation in Sweden and elsewhere and FAG RAG relies on it, among other publications, to keep up to date on the activities and ideas of gay men

in other parts of the world. GLAD is also representing a gay prisoner in Idaho who is serving a life sentence for consensual sex with a teenage male. The man's original conviction on the charges was overturned just before he was due to be paroled. On retrial for the same charges, the judge increased his sentence from the original eight years to the life sentence he is now serv-

GLAD is part of the foundation for Individual Rights (NEFIR), a coalition of gay public interest law foundations which also includes The Lambda Legal Defense & Education Fund (New York), the Lesbian Rights Project (San Francisco), the Texas Human Rights Foundation (Houston) and Gay Rights Advocates Second Edition of the National Lesbian & Gay Attorneys Referral Directory(ordering information is available from GLAD, 2 Park Square, Boston, Ma 02116).\_

#### MERCK SHARP &DOHME GIVE

The American Liver Foundation today announced that it has launched an estensive educational outreach program on the hazards and prevention of hepatitis B infection aimed at the gay male community, a population at great risk of contracting the disease.

The public information porgram is believed to be the most extensive ever conducted in the gay press.

The educational message, developed after sampling the reactions to several proposed formats by a group of gav leaders at a recent conference in Dallas, is being placed in 88 national and regional gay periodicals. plans for continuing the campaign into 1983 have not been completed. Full-page public education messages are being placed

in each publication and premium positions--such as back cover--have been used wherever abailable. During the awareness campaign, the message will appear in each issue of the weekly, bi-weekly or monthly publications selected.

According to the American Liver Foundation, this approach was developed because there is a need to disseminate detailed, factual information about hepatitis B infection and the protective effectiveness of Heptavax-B. a vaccine developed by Merck Sharp & Dohme. The program is being funded by a grant from the pharmaceutical comp-

Although the gay press has given a significant amount of editorial space to news about the vaccine's availability since it was introduced in July, 1982, the Foundation wanted to enhance this effort to help prevent this disease that causes tremendous human suffering and economic burden to our nation.

GPA President, Joe DiSabato, announced today that four noted free-lancers are now contributing articles to the developing GPA Wire Service.



#### PATRICK COWLEY GIVES SELF/MUSIC

Because HE was laboring against the clock, disco producer Patrick Cowley never worked harder than he did in the final year of his brief life.

Fighting off the debilitating effects of an immunological deficiency, Cowley managed to write, arrange and record three complete albums and two full-fledged danceclub hits, while also adding his electronic keyboards to a handful of studio sessions.

Last month he finally succumbed to pneumocystis carinii pneumonia, resulting from one of the mysterious diseases now plaguing the gay community. The 32 year old Cowley had six records on national pop, soul and disco charts and was obviously on his way to becoming a major force in contemporary music when death intervened.

"Right now, you can look at any record chart and see Patrick's handiwork," said Marty Blecman, Cowley's partner in the San Francisco-based disco label Megatone

The late producer's last undertakings--his second solo album, "Mind Warp," his record with vocalist Paul Parker, "Right on Target," and his collaboration with the bizarre, incandescent soul singer Sylvester, "Do Ya Wanna Funk"-are selling so well that, according to Blecman, "people in the dance end of the music business are referring to "the Cowley sound.' It's electronic, but energetic, and we've got enough of his music still in the can to release Patrick Cowley stuff for the next four or five years."

The irony that disco, a good-time party music, was forged by an invalid did not escape Cowlev's associates. Nonetheless, both Blecman and Paul Parker agree that music may have prolonged their friends life. "At first, I thought his illness was the success-sickness syndronme, said Blecman, "but, in truth, the music pulled him through his first bout with pneumonia last Descember and probably kept him alive an extra year."

'After hospitalization, he told us that he just wanted to record one more album," added Parker. "Then, we couldn't keep him out of the studio. At one point, he recorded two albums over about five weeks. He'd spend 20 hours straight to complete something and, when finished, he' collapse.

"Two months before he died, he couldn't work anymore. There were all sorts of complications, because the most minor bacteriological disturbances can go wild when the immune system breaks down.

"Due to the widespread fear of the AID syndrome in the gay community, a lot of Patrick's friends were reluctant to come by and see him. He had to cope with it all"

Cowley died on November 12. "He was angry about having to die," said Blecman. "He saw success in his own time, and could afford to die on his own terms. He bought a house, essentially to die in, and had aroundthe-clock nurses.

"Not everyone who falls victim to these diseases can deal with the end like this. He died with dignity." ---Michael Snyder \_\_\_\_

#### **LAME DUCK CONGRESS SUPPORTS AIDS**

WASHINGTON, D.C. --- The Gay Rights National Lobby's (GRNL) effort to increase funding for research on AIDS (Acquired Immune Deficiency Syndrome) met with tremendous success during the lame duck session of the Congress. Congress passed a Continuing Resolution funding the government for the rest of the fiscal year which runs through September 30, 1983. In the Continuing Resolution, \$2 million was appropriated for AIDS research to be conducted by the Center for Disease Control (CDC). In fiscal year 1982, only \$500,000 for AIDS reasearch was provided. The funds for AIDS represents a significant victory since there were only two other new health related programs funded during the entire 97th Congress.

Comenting on GRNL'S success in obtaining the increase in CDC funds for AIDS, Steve Endean, Executive Director of GRNL pointed to the extensive use of the field network in securing support from key members of Congress: "Without the persistent efforts of GRNL's Field Associates and other key contacts, particularly in those states with Senators and Representatives on the Appropriations Committees, the GRNL lobbying effort would not have met with the same degree of success. This victory demonst-

rates that the gay community must continue to utilize the same constituent lobbying techniques which are effectively used by other grass roots organizations." Endean also praised the work of Bart Church, GRNL's researcher on the AIDS project, who has coordinated the constituent lobbying effort and helped build support from allied organizations.

The coalition assembled by GRNL to support increased funding was an important element in the success of the lobbying effort. Included among the groups which pledged their support for AIDS funds were the American Public Health association, the American Psychiatric association, the National Association of Social workers. the American Psycholical Association and the National Hemophilia Foundation. GRNL plans to expand this coalition in order to increase awareness and support for AIDS research.

In the continued effort to expand the federal commitment to AIDS. GRNL will be focusing increased attention on the National Institutes of Health (NIH). While the Center for Disease Control has made AIDS one one of its top priorities. NIHcontinues to lag behind in devoting resources to AIDS research. An increased commitment by the National institutes of Health is essential because NIH performs the reserch necessary to gain an understanding of the medical aspects of the disease while CDC concentrates on the surveillance of incidence and other important statistical gathering functions. GRNL intends to further utilize the field network in attaining this goal.

Rules and regulations for pcba

1. The P.C.B.A. will be limited to 36 teams, which is the maximum amount of lanes at the present bowling alley. Pre-registered teams of five members will have first choice for participation. Thereafter, a team must have at least 4 players to participate as a team.

#### REPORT from the lesbian/gay pride '82, Steering committee



Here it is already Dec. We'd like to let everyone know what we've been doing. After the candlelight vigil on June 27th ended the nine day celebration of over 25 events all of us who had been organizers gave in to our exhaustion. We were burnt out. None of us had truly realized in the beginning how much time and effort it would take. And ounce the ball was rolling we just hung on and kept up with the pace.

For months letters and articles continued to appear in the press either denouncing (mostly) or occasionally defending the rally and the organizers. We have listened to the criticisms and have considered them. Some were clearly valid. Some were misinformed and others were simply spiteful.

An example of misinformation is the confused usage of the word separatists. A lesbian separatist is a woman who chooses not to work or associate with men. By definition none of the women who worked on Lesbian and Gay Pride '82 could be separatists. Every committee was cocoordinated by a man and a woman and there was sexual parity on the steering committee. Lesbian and Gay Pride '82 events were designed to bring men and women togetherclearly not a separatists goal. However, bringing men and women together confronts us sometimes painfully with our differences. Our hope is that gay men and lesbians will learn to talk about their differences in a way that increases understand and builds community.

GAY/LESBIAN PRIDE '82 guidelines Opposed these attitudes and behaviors that oppress: RACISM, SEXISM, CLASSISM, AGEISM, HANDI-CAPPISM, RELIGIOUS AND POLITICAL INTOL-LERANCE. The groups goal was to sponsor events and activities that built community while respecting differences.

One problem with Lesbian and Gay Pride celebrations in Portland is that every year new people take on the task and in many ways are forced to reinvent the wheel. We had planned to write up a "How-to (and How-not-to)" booklet but the project has proved too much for our dwindling numbers. Instead, we will archive and index our considerable materials. Included will be the evaluations, budgets, minutes from all meetings, ... etc. The archive will be kept in a public place and plans are being made to house it at the Metropolitan Community Church.

During the last months we have also been tying up business details. We have raised enough money to cover expenses with some to spare. This money will be applied to Lesbian and Gay Pride '83 consistent with the gudelines under which it was solicited.

Lack of beer at the rally angered and disappointed many people including ourselves. We estimate a financial loss of \$1000. Other people din't seem to mind. We were unprepared, however, for the suspicion that we never had intended to have beer. There is absolutely no validity to it. Others were critical of our failure to find an alternative source of beer. Given our limitations (no bottles in the park, for instance), our small resources and the large number of people in the park, none of the last minute options seemed workable. As we began to retrace what had happened it became clear that the extablishment we had contracted with had failed to meet its LESBIAN/GAY MARCHERS REACH WATERFRONT PARK June 20,1982 responsibilities. Discussion with them proved fruitless as did negotiations though an attorney. Our solution to the beer truck problem is to point out the need for a community arbitration/mediation system and encourage its organization.

We feel that our process was an open and accessible as we could make it- initial grassroots organizing forums where anyone who wanted could contribute to the guidelines, open regular steering committee meetings, public posting of minutes and budgets and a built-in grievance procedure open to anyone in the community.

If you're interested in organizing next year come to a meeting on Monday, January 10, at 7:00 p.m. at the Metropolitan Community Church (24th and NE Broadway). For those of you who had strong feelings about this year, come and get involved. Put your energy to constructive use.

What you get is what you will help to make. Finally, we wish to thank all of our supporters, business and bar owners, volunteers, the security, publicity and gaycare workers, all the committee members and the community organizations for their contributions and hard work. Our hope for the controversy generated is that it lead to a thoughtful awareness of our very real differences and the beginnings of dialogue. And to the 2,500 women and men chanting and dancing your way into waterfron Park, you-we-were beautiful.

#### COBALT

By Nathan Aldyne St. Martin's press \$9.95

A resort town is a fractured parody of a community. An unrealistically large number of unrelated people converge on a single place where their only enterprise is play. Personalities are seldom defined by any context other than physical appearance. Character never has to undergo the tests of time or challenges of fortitude; there's only enough exposure of one person to another for judgement to be made on the basis of impressions of friendliness or physical attractiveness.

Provincetown, Massachusetts is an archetypal resort. ts winter population of 3500 bursts to include as many as 50,000 souls on a summer weekend. At least half that number will be gay men and lesbians. Who are these people? where did they come from? The questions are meaningless to the usual observer. That is, until dead odies begin to litter the Cape Cod landscape.

There are two people in Provincetown who take it upon themselves to find out why murders are happening all around them in the oceanside town. Daniel Valentine and Clarisse Lovelace are no strangers to violent death. They made their debut in mayhem in last year's Vermilion, published by Avon Books. In that novel their talented amateur sleuthing solved an apparently political murder in Boston's gay community.

The shift in locale isn't really surprising. Province town is, in fact, a logical place for Valentine, an ever popular tender of gay bars, to move to. When Clarisse finds herself incapable of surviving summer in the city without him, it's just as logical for her to join him in the fishing village turned ghetto on the tip of Cape Cod.

But the idea of sitting on a wind-cooled, sun-bleached beach is, to say the least, not all it's stacked up to be. There's the unrelenting tackiness of it all. Bad taste seems to be the sine qua non of the tourists. (So much for the sterotype of gay men as aesthetics.) And, don't forget, there are all those corpses that seem intent on disrupting Val and Clarisse's individual campaigns of conquests on the men in the place.

In this, the second detective novel in what promises to be a continuing series, Nathan Aldyne has once again used gay New England as his setting for an entertaining mystery. The same quick dialogue and vivid description that made Vermilion such an entertaining mystery are at work in Cobalt. The characters are vividly drawn. Their realistic daily lives move forward seemingly under their own power carrying a willing reader deeper into the story. The laughs and giggles come easily. But the accuracy of the portraits is also cause for reflection.

Cobalt is a harsher view of gay life than Vermilion. Though it certainly will still pass muster of even the most critical political reader, it is a gritty book, not a fluff volume of party line dribble. It's strangely more realistic than Vermilion even as individuals are presented in an even more outrageous manner. The chapter describing the White Prince cleaning house after he mistaken a hit of speed for his morning Vitamin E tablet has to be one of my favorite slices of gay life. The morning ritual of Valentine introducing his previous night's trick to Clarisse will always have a soft spot in my heart; it was a perfect replay of my early gay life with a straight room-mate.

This accurate characterization is a forte of Aldyne, a writer who also sticks firmly to the conventions of mystery writing. There is no lack of suspects, no dearth of conflicting clues, and no easy, expected solution.

The result is a rare achievement: a very good detective novel that will pass scrutiny of the most demanding mystery buff--of whatever sexuality--and a book which also portrays an accurate picture of gay life in America. JOHN PRESTON

#### NATHAN ALDYNE: A PORTRAIT OF BOTH OF HIM

Two or three times a week for the past five years a man from Medford, Massachusetts has driven into Boston to rendezvous with a friend. The two of them proceed to make the rounds of the city's gay bars. Are they clandestine lovers? Detectives? Or just a new kind of urban weirdo? None of the above. They are Nathan Aldyne and they are going about the business of writing.

There are many reasons for an author to use a pseudonym. I suspect that gay readers assume that the closet is the most common one when it comes to novels about our life styles. That's hardly the motivation Michael McDowell and Dennis Schuetz had for writing Vermilion (Avon books, 1980) and Cobalt (St. Martin's Press, May4, 1982) under the name Nathan Aldyne.

The first two at first had to accept an iron-clad rule of publishing: fiction can not appear to be written by a team. The readers' credibility would be shaken, at least in a first novel. Not that they're necessarily upset with that ruling. The two men listen and observe together during their ritualistic outings to places with names like Rustlers, the Ramrod, and Sporters. They watch costumes develop, note specific mannerisms, chronicle the evolution of gay language and style. They are sharing a search for a new character, or hoping to find a new situation to solve a problem in one of their

When all the details have been compiled and an outline agreed upon, Schuetz will write a first draft of a section of a book. That fragment will be handed back and forth for rewriting at least five times until a unique voice has been created; a style will be achieved which is totally different from either of their own individual writings and which deserves to be credited to a different name for either of their own.

Nor are the Aldyne books their only collaboration. clood Rubies, a novel of psychological terror, will be published by Avon Books this spring under another pseudonym, Axel Young.

There's another reason for the multiple name game. The duo work at writing. They are not dilettantes occasionally sratching out a page of prose. They produce so much, in fact, that they would be flooding the literary market it they were'nt shifting from one arena to another. Even as you read Cobalt, they are well into the next volume in the valentine and Clarisse detective series; they've done the draft for the next Axel Young novel; each is pounding away at his own separate works. The quality of the books is much too high ever to use words like "hack writer" when the two men are talked about. But, they certainly are intent on being pro-

The idea of writing gay themed detective books might seem strange to some other writers. After all, the monetary rewards of mystery novels in general are already notoriously small, and when they're done in a subcultural setting, the market would seem even less lucrative. "We don't do this for money, really," explains Michael. "I'm very conscious of these books being my contribution to the movement. What we set out to do. and I think we've done quite well, is to write about the gay community without any characters who are immersed in guilt or self-doubts. We've described a population of people who are going about the business of life. And, we've done it while having great fun working within the genre of detective novels." -- John Preston

Board members of the Right to Privacy, PAC, Oregon's largest gay political action committee, today announced their intention to form the Right To Privacy Lobby. This new organization will spearhead the drive for lesbian and gay male legislative issues in the upcoming 1983 Oregon legislative session. The Oregon Legislature meets only

"With the political clout and sophistication we've gained by the enormous success of our campaign efforts (the PAC raised over \$21,000. during the campaign season) we would be doing an injustice to the lesbian and gay community were we not to form a progressive, highpowdered lobby." stated Eugene lesbian attorney Dana

DISAPPOINTMENTS AND NATIONAL FUNDS

Two major defeats proved most disappointing for gays-Ruth MCFarland's unsuccessful attempt to unseat Denny Smith in Oregon's Fifth Congressional District and Ted Kulongoski's defeat in the governor's race. Right to Privacy donated \$5500. to the Kulongoski campaign and termed his race "most important for Oregon's gays". The national gay PAC, the Human Rights Campaign Fund gave \$5000., the legal limit, to the McFarland race. Weller, in addition to his Oregon post is the vice-treasurer of the national gay PAC. The Human Rights Campaign Fund also donated over \$3000. to Les AuCoin's re-election campaign and \$500.

\$19,000 IN LOCAL AND NATIONAL MONEY DONATED "The Right To Privacy, PAC donated over \$10,000 to Oregon candidates (most of which was raised at the PAC's annual Lucille Hart Dinner held at Portland's Benson Hotel) and close to \$9000 more was given to Oregon Congressional candidates by the national gay PAC the Human Rights Campaign Fund, "Weller stated, "The the list of flawless performances by supporting characters funds were given wisely and with very positive results."

"The 1983 Oregon Legislative session will mark ten years of the introduction of gay civil rights legislation. With our new strength and greater political sophistication this could be the session for Oregon gays to be granted basic civil rights."




you take it home with you every night".
