## ORDINANCE No. 135892

An Ordinance transferring appropriation of \$115.00 without resources from the General Fund to the Sloan Fountain Trust Fund, transferring \$25,490 within the Sloan Fountain Trust Fund, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that additional appropriation of \$115.00 is needed in the Sloan Fountain Trust Fund to supplement the appropriation established in the Budget Ordinance; that this additional appropriation is necessary to permit the transfer of the total amount in the Sloan Fountain Trust Fund to the Capital Improvements Fund for the Downtown Park Project as provided in Ordinance No. 135786 passed December 27, 1972; that such a transfer is permitted by ORS 294.450; that this transfer should be authorized; and that the appropriation already budgeted in the Sloan Fountain Trust Fund as Improvements should be transferred to Transfers to Other Funds; now, therefore, appropriation of \$115.00 without resources is hereby transferred from the General Fund appropriation Reimbursable Expenditures (5191.798) to the Sloan Fountain Trust Fund appropriation Transfers to Other Funds (6975.790), and \$25,490 is hereby transferred within the Sloan Fountain Trust Fund from Improvements (6975.760) to Transfers to Other Funds (6975.790).

Section 2. Inasmuch as this Ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the appropriation transfers in Section 1 of this Ordinance may be authorized without unnecessary delay; therefore, an emergency is hereby declared to exist and this Ordinance shall be in force and effect from and after its passage by the Council.
