The Lower Southeast Rising Area Plan proposes land use map changes to expand opportunities for neighborhood businesses and housing in the Brentwood-Darlington neighborhood and other nearby neighborhoods. The plan also includes recommendations for future active transportation projects to make it safer and easier to access local destinations. The land use map changes include proposed amendments to the Comprehensive Plan Map and Zoning Map, primarily expanding multi-dwelling and commercial/mixed use zoning, and propose a new Brentwood-Darlington neighborhood center to serve as a hub for commercial services.
