RESOLUTION RELATING TO THE ANNUAL BUDGET FOR THE DEPARTMENT OF DEVELOPMENT AND CIVIC PROMOTION FOR THE FISCAL YEAR BEGINNING JULY 1, 1970, AND ENDING JUNE 30, 1971, AND MAKING APPROPRIATIONS AND AUTHORIZING EXPENDITURES OUT OF THE URBAN REDEVELOPMENT FUND, \$9,808,000

WHEREAS, the Multnomah County Tax Supervising and Conservation Commission has voted the budgeted amounts with no objection, but has not yet considered recommendations, if any, in the budget for the PORTLAND DEVELOP-MENT COMMISSION as included in the Annual Budget of the City of Portland for the fiscal year beginning July 1, 1970 and ending June 30, 1971, as filed with said Multnomah County Tax Supervising and Conservation Commission on June 9, 1970; and

WHEREAS, no changes have been made from the amounts as authorized by ORS 294.435(2); now, therefore, be it

RESOLVED, that the budgeted amounts of the PORTLAND DEVELOPMENT COMMISSION budget as voted with no objections by the Multnomah County Tax Supervising and Conservation Commission is hereby adopted, subject to recommendations, if any; and, be it

FURTHER RESOLVED, by the PORTLAND DEVELOPMENT COMMISSION as follows:

 To authorize expenditures of the Department of Development and Civic Promotion for the fiscal year beginning July 1, 1970, and ending June 30, 1971, in connection with urban renewal and to make the following specific appropriations from the Urban Redevelopment Fund:
