We represent Makayla "Topaz" Arnold. During the late afternoon of May 23, 2024, our client was returning from biology class when they stopped to attend a peaceful assembly of students near the east garage on campus. Like many other PSU students, our client condemns acts of violence in Gaza, and has never participated in any acts of violence on campus.

While our client stood in solidarity with other peaceful assemblers, officers violated ORS 161.233 and PPB Policy 1010.00 by physically assaulting our client without first giving a verbal warning that physical force may be used, and without considering alternatives to physical force.

The attached video of the incident seemingly shows that Chief Halliburton initiated the use of physical force against peaceful assemblers, well in advance of any purported medical emergency. In any event, our client intends to enter the medical field upon graduation, and they wish Chief Halliburton a full and speedy recovery.

The Underdog Law Office has been retained to investigate and prosecute a claim of negligence, battery, assault, and related torts against you resulting from the unlawful use of force against our client near the Neuberger Center at Portland State University on May 23, 2024. As a result of your unlawful use of physical force, our client experienced medical bills, pain, mental suffering, emotional distress, and humiliation.
