

ORDINANCE No. 137845

An Ordinance authorizing the Purchasing Agent to advertise and receive proposals for furnishing Mercury-Vapor Luminaires, Mast Arms, and Photo Controls to the Bureau of Lighting, authorizing a contract therefor, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Purchasing Agent hereby is authorized and directed to advertise and receive proposals for furnishing Mercury-Vapor Luminaires, Mast Arms, and Photo Controls to the Bureau of Lighting, Department of Public Works, in accordance with the specifications therefor filed in the Purchasing Division on February 7, 1974, which specifications hereby are adopted and by this reference made a part of this ordinance.

Section 2. The Mayor and the Commissioner of Public Works hereby are authorized and directed to enter into a contract with the most responsible bidder submitting the most advantageous bid for the item mentioned in Section 1 hereof. The Council hereby reserves the right to reject any and/or all bids, in whole or in part, and in the event that no satisfactory bid is received, the Purchasing Agent hereby is authorized to readvertise therefor on the same basic specifications until a satisfactory bid is received. The Mayor and the Auditor hereby are authorized to draw and deliver warrants charged to the 1973-74 Budget, Street Lighting, Bureau of Lighting, Repairs and Maintenance-External (332.618*) when demands are presented, approved by the proper authorities.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there may be no delay in authorizing a contract for the item set forth in Section 1 hereof, this ordinance should be effective immediately upon its passage; therefore, an emergency hereby is declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.


