## **Holst - Dustin Furseth, Senior Associate**

Commissioners,

First and foremost, I want to thank the City Council for recognizing, elevating, and celebrating good design and the important role it plays in the public realm of our vibrant and dynamic city.

My name is Dustin Furseth, Senior Associate at Holst Architecture and the design lead for Hollywood HUB. It is with great pleasure that I testify on behalf of the design and construction team about our collaboration between Bridge Housing, TriMet, O'Neill Walsh Community Builders, and the City of Portland. More specifically, I would like to highlight the positive impact the Portland Design Review process had on the project.

Let me set the stage: Dec '21, we were struggling with a host of constrains including a Federal HUD "DDA" funding boundary that danced haphazardly across the blank site, a relic of a long-demolished freeway ramp from a bygone era that pre-dated the MAX line. It limited our ability to utilize the site and so we voluntarily brought some compromised urban planning ideas before the Design Commission through the optional Design Advice Request hearing process to show the challenges and get some feedback before we moved any further.

This was an incredibly complex project with a wide array of challenges and required balancing a variety of constraints. From overlapping regulatory requirements of multiple bureaus, utility companies, and jurisdictions, to addressing the needs of the neighborhood and broader community, architecture like this cannot be regulated through standards alone. This level of design requires discussion, collaboration, and compromise. Portland's collaborative and discretionary design review process was essential to our success, and it simply made the project better.

That said, the first hearing was brutal, and it was just what the project needed. The commission pointed out many of the flaws and failures in the early designs caused by the HUD DDA boundary, and most importantly encouraged us to question just how "un-movable" the DDA boundary really was. Enter Senator Wyden's Office, they helped open lines of communication with several Federal agencies and championed the approvals needed to make this project great. Thank you to Senator Wyden and his staff for recognizing the importance of quality affordable housing.

From that moment forward, the project feels like a list of successes that I am truly humbled to be part of. We were able to shift our focus to deliver a design solution that enhances the public realm for all Portlanders and provides new housing stock for those who need it most. Architecture of quality and permanence, public spaces that connect us, unite us, and capitalize on the proximity to our city's mass transit system.

When we appeared before the design commission in our official Land Use approval hearing, it felt like a celebration. And it was.

I want to thank our planner Tim Heron for his constant attention and dedication to Hollywood HUB's success, and I want to thank our Portland Design Commission for helping us think outside the box for the betterment of our city.
