


- Hayu Tilixam
- Tistilal Village Redevelopment
- Neerichokikoo Food Sovereignty Project



Hayu Tilixam

- 50 newly constructed, affordable, multifamily housing units in the Cully neighborhood.
- Designed by and for low-income, Native American and BIPOC families earning 60% AMI and below.
- Includes 9 permanent supportive housing units for Native American individuals experiencing homelessness.





NAYA & PCEF Collaborations

- Tistilal Village Redevelopment
 - \$1,804,000 for energy efficiency, medicinal gardens and resiliency measures
- Neerichokikoo Food Sovereignty Project
 - \$3,694,885 to convert 4.2 acres to a diversified farm, playscape, community gathering and ceremonial spaces, an Indigenous games field, a First Foods preparation and cooking space, traditional plant medicine garden, hedgerow of native trees, Camas swale and restoration areas focusing on native perennial plants
- NAYA staff participated in the Climate Investment Plan Roundtables

Bylaws and working agreements

Presented by the Bylaws subcommittee



Bylaws – Amendments proposed to conform to PCEF code changes passed in October 2022

Role

- Previous Make grant funding recommendations to Mayor and City Council
- Amended Recommend Climate Investment Plan to City Council
- Language alignment Add reference to "workforce priority populations" to match code and add "people experiencing gender-based discrimination in the workplace".
- **Funding areas** Add "transportation decarbonization" and "other projects that reduce or sequester greenhouse gasses" to match code
- **Meeting frequency** Change from minimum 10 times/year to 6 times/year to reflect Committee role and provide more flexibility



Working Agreements – Purpose and Structure

• **Purpose:** Provides a framework for accountability between Committee members and articulates the norms of meetings and interactions between Committee members, BPS staff, the media, and interest groups. Can be modified at any time with Committee approval and is to be reviewed every 2 years.

Bylaws and Working Agreements – Additional edits since July meeting

Bylaws

- Clarification of Committee Member volunteer role and stipend option.
- Edit to better capture the change from grant approval to CIP recommendation.

Working Agreement

• Edit to recognize the 2-term reality of current committee members.

Modified consensus decision making process

- **Proposal** put forth for consideration by Committee member
- **Temperature check** each Committee member indicates how comfortable they are with making an affirmative decision
- Discussion additional discussion if needed
- Amendments Committee members can offer amendments to the original proposal
- **Decision** each Committee member can 1) affirm the proposal, 2) stand aside, or 3) indicate that "no" they do not support the proposal. Note that standing aside is counted as a decision to affirm for the purposes of approving a proposal.

The following minimum number of affirmative decisions is required for a decision to represent the position of the PCEF Committee.

- When 6 or 7 Committee members are present : 5 Affirmative decisions
- When 8 or 9 Committee members are present : 6 Affirmative decisions
