

ORDINANCE No. 139371

An Ordinance accepting a street deed for a tract of land in Section 29, T.1S., R.1E., W.M., to widen the intersection at S.W. 42nd Avenue and S.W. Galeburn Street, and declaring an emergency.

The City of Portland ordains:

Section 1. That the Street deed to the following described tract be and is hereby accepted for street purposes:

A parcel of land in Section 29, T.1S., R.1E., W.M., described as follows:

Commencing at the southeast corner of Lot 8, Block 2, SOUTHWOOD; thence southerly along the southerly extension of the east line of said Lot 8, a distance of 25.0 feet to a point on the southerly line of S.W. Galeburn Street (25.0 feet wide) and the true point of beginning; thence continuing along said southerly extension 25.0 feet; thence easterly 25.0 feet southerly of and parallel to with the southerly line of S.W. Galeburn Street (25.0 feet wide) a distance of 25.0 feet to a point in the westerly line of S.W. 42nd Avenue (25.0 feet wide); thence northerly along said westerly line 25.0 feet to a point on the southerly line of S.W. Galeburn Street (25.0 feet wide) which lies 25.0 feet westerly of the point of beginning; thence westerly along the southerly line of S.W. Galeburn Street (25.0 feet wide) 25.0 feet to the point of beginning.




