

Ordinance No 20949

An Ordinance revoking the license of Philip Rosumny to conduct an auction house, and authorizing a warrant on the General Fund to provide for the refund of the unexpired portion of license fee paid for said license.

The City of Portland does ordain as follows:

Section 1: That the license issued to Philip Rosumny to conduct an auction house at No 246 Burnside Street during the current quarter, and numbered 23815, dated January 5, 1910 be and the same is hereby revoked.

Section 2: That the Mayor and Auditor be and they are hereby authorized to draw a warrant on the General Fund, chargeable to the appropriation for relief of certain persons, in the sum of \$9.75 to provide for the refund of the amount of the unexpired portion of the license issued to said Philip Rosumny to conduct an auction house at No 246 Burnside Street.

Section 3: Whereas there is an immediate necessity that this ordinance shall take effect upon its approval by the Mayor, an emergency is hereby declared and said ordinance is hereby declared to be necessary for the immediate preservation of the health, peace and safety of the people of the City of Portland for the following reasons: It is necessary to revoke said license for the reason that the ordinances of the City of Portland regulating auction houses have been violated. Therefore this ordinance shall take effect and be in force immediately upon its approval by the Mayor.

Revoking license of Phillip Rosmany to

An Ordinance revoking the license of Phillip Rosmany to
conduct an auction house, and authorizing a warrant on the

The City of Portland does ordain as follows:

Section 1: That the license issued to Phillip Rosmany
to conduct an auction house at No 246 Burnside Street during
the current charter, and numbered 23815, dated January 2, 1910,
and the same is hereby revoked.

Section 2: That the Mayor and Auditor be and they are
hereby authorized to draw a warrant on the General Fund,
chargeable to the appropriation for relief of certain persons,
in the sum of \$9.75 to provide for the refund of the amount

of the unexpired portion of the license issued to said Phillip
Rosmany to conduct an auction house at No 246 Burnside Street,
Section 3: Wherein there is an immediate necessity that

this ordinance shall take effect upon its approval by the
Mayor, an emergency is hereby declared and said ordinance is
hereby declared to be necessary for the immediate preservation
of the health, peace and safety of the people of the City of
Portland for the following reasons: It is necessary to revoke
said license for the reason that the ordinances of the City of
Portland regulating auction houses have been violated. There-
fore this ordinance shall take effect and be in force immedi-

ately upon its approval by the Mayor.
