# 1. Independent Police Review (IPR) Division Work Plan / Accomplishments

#### **Volunteer Appreciation**

## IPR Responds to Scene of Officer-Involved Shooting:

Director Constantin Severe responded to the scene of the officer-involved shooting which occurred in Southeast Portland on March 23. The investigation is ongoing.

#### Changes to Case File Review Process and Timeline:

On May 13, 2015 at 2:00 pm Director Severe will be presenting proposed changes to City Council regarding the Case File Review process and the timeline for requesting an appeal. These changes are in accordance with the Department of Justice settlement agreement and were developed with the cooperation of CRC members and recommendations from the public.

A community engagement meeting about the CRC Code Changes has been scheduled for Tuesday April 21<sup>st</sup> from 5:30 pm to 6:30 pm in the Lovejoy Room. Everyone is welcome to attend.

## **IPR Community Outreach**

Community Outreach Coordinator Irene Konev attended and networked at Coffee and Issues Networking event at Oregon Association for Minority Entrepreneurs, East Precinct Involved Citizens meeting, and at Women's History Month Kick off Breakfast at City Hall. Konev and IPR Investigators participate in monthly dialogues with Sisters of the Road Café customers, and made a presentation to the staff of Outside In and New Avenues for Youth. IPR Investigator Casey Bieberich tabled and engaged in dialogue with Spanish-speaking parents at the 5th Annual Latino Parent Conference. Konev presented to the Human Rights Commission, and led a community engagement tour of City Hall with Burmese immigrant community members. As part of the Slavic Advisory Council, Konev facilitated a listening session for the Slavic community and Multhomah County Chair Deborah Kafoury.

IPR Director Constantin Severe met with the director of National Alliance on Mental Illness Multnomah, and has a meeting scheduled with key community leaders throughout April to engage community in the upcoming CRC City Code changes. Severe also attended the COAB meeting.
