Director's Report

1. Independent Police Review (IPR) Work Plan / Accomplishments

IPR Responds to Scene of Officer-Involved Shooting:

Director Constantin Severe responded to the scene of the officer-involved shooting which occurred in the Brooklyn neighborhood of Southeast Portland on May 17. The investigation is ongoing.

Changes to Case File Review Process and Timeline:

On May 13, 2015 at 2:00 pm IPR Director Severe presented proposed changes to City Council regarding the Case File Review process and the timeline for requesting an appeal. The code change was a result of recommended changes stated in the Department of Justice settlement agreement and were developed with the cooperation of CRC members and recommendations from the public.

IPR Community Outreach

The IPR Information and Community Engagement Session was held on Wednesday May 27th in the Portland Building from 5:30 to 7:30 pm. Community stakeholders and CRC members attended, learned about the IPR complaint process and made recommendations for improving police accountability in Portland.

To engage stakeholders in the IPR Information and Community Engagement Session, Community Outreach Coordinator Irene Konev presented to IRCO Africa House staff, Human Rights Commission, African American Advisory Committee, Slavic Advisory Council, Alliance for Safer Communities, and Community Oversight Advisory Board (COAB) Executive Committee meeting. This information was also shared at the COAB monthly meeting.

Konev met with leaders of the Iraqi Society of Oregon, spoke at Race Talks, attended and networked at Say Hey Northwest, Russian Speaking Youth Leadership Conference, and at Asian Pacific Network of Oregon.

IPR intern Kaysey Crump set up several high school presentation for the IPR director and staff. Classroom presentations were held Parkrose High School and Jefferson High School. At Roosevelt High School, IPR staff participated in Community Conversations on several topics including public safety and police accountability.

International Visitors

Through coordination of the World Affairs Council, IPR Staff and CRC members met with delegates from Papua New Guinea. The delegates learned about the IPR complaint process, the role of the IPR in officer involved shootings and in-custody deaths, and IPR oversight of police interactions with community members struggling with mental health.

Community Feedback

- Immigrant community leaders seek opportunities for connections and relationship building opportunities with Portland Police Bureau members.
- Portland's youth shares concerns about racial profiling and fear negative interactions with police.
