Director's Report

1. Independent Police Review (IPR) Work Plan / Accomplishments

Community Outreach

IPR Community Outreach Coordinator Irene Konev, Assistant Program Manager Rachel Mortimer and CRC member Neil Simon attended the Lents Neighborhood Association meeting. They presented the IPR commendation and complaint process and heard concerns about the growing population of folks struggling with houselessness in their community and shared their frustration of a lack of resources to meet the needs of the community. Those in attendance also expressed their concerns that their neighborhood may not get the same response from the Portland Police Bureau as other neighborhoods.

Konev helped coordinate the second Slavic Advisory Council Resource Fair for Slavic/Russian-speaking community. This event drew over 100 people, consisting of elected officials, Slavic/Russian-speaking community leaders, youth, seniors, non-profit organizations that support the Slavic/Russian-speaking community, as well as key pastors from this community.

The Portland Police Bureau brought several divisions including the Chief's Office, Cadet Program, Drug and Vice, Traffic Division and gave workshops on traffic and public safety. Konev coordinated six students from the PSU Russian Flagship Program to attend and translate at the event. It was an informative and enjoyable evening of new connections for all.
