1. Independent Police Review (IPR) Work Plan / Accomplishments

CRC Transitions

CRC member Roberto Rivero resigned from CRC after serving more than four years. IPR would like to thank Roberto for his contributions to Portland's police oversight. His commitment to community outreach, and a voice in the community will be missed. Thank you, Roberto for your years of service.

Hillary Houck was appointed by Portland City Council on March 14th to begin her three-year service on the CRC. A new member will be joining the CRC at the next meeting on May 2nd.

Community Outreach

IPR Community Outreach Coordinator Irene Konev attended and networked at Hispanic Pros Spring Networking Event, Say Hey Northwest, Urban League Career Connections Job Fair, Slavic Advisory Council, and at I AM 2018: Remembering Reverend Dr. Martin Luther King Jr., a celebration of his life and legacy of work.

IPR Director Constantin Severe attended and engaged with community at the Forum on Public Safety and the DOJ Settlement Agreement.

Youth Engagement

IPR Program Manager Assistant Rachel Mortimer presented on the IPR police oversight system to 6th graders of Cottonwood School of Civics and Science when they visited City Hall as part of their study of the Civil Rights Movement and Portland Black History.

International Visitors

Through WorldOregon, IPR hosted two international delegation groups to talk about IPR's role in police oversight in Portland. One group of delegates was from Armenia, Croatia, Macedonia, Poland, Slovakia, and Ukraine. A second group of delegates was from Algeria, Benin, Burkina Faso, Congo, Kenya, Cote d'Ivoire, Malawi, Mali, Nigeria, Senegal, South Sudan, Uganda, and Zimbabwe. This was a great opportunity to engage in dialogue about police oversight in Oregon and learn about policing in other countries.
