### **1. Independent Police Review (IPR) Work Plan / Accomplishments**

#### **New IPR Deputy Director Selected**

City Auditor Mary Hull Caballero has named Dana Walton-Macaulay as Deputy Director of Independent Police Review. Ms. Walton-Macaulay's first day will be August 19. Walton-Macaulay currently serves as the director of the Office of Student Conduct at Portland State University and has more than 20 years of experience in higher education administration, specifically investigating and adjudicating conduct matters. She holds a bachelor's degree in psychology from the University of Missouri-Columbia, a master's degree in higher education administration from the University of Arkansas-Fayetteville, and a Juris Doctor from the University of Arkansas William H. Bowen School of Law.

#### **Update on Code Change**

The Portland City Attorney's Office will be presenting proposed changes to City Code on August 28, 2019. The changes will amend 3.20.140(C)(2) to clarify that a CRC member will serve on the Police Review Board in all cases involving use of force.
