Proposed code amendments

Committee update:

Code language enabling the use of PCEF's interest on a one-time basis

- D. Notwithstanding the purpose in Subsection 7.07.020.A. and the funding criteria in Subsections 7.07.060.A.-C. above, the City Council may allocate funding for fiscal year 2024-2025 expenditures in an amount that is less than or equal to the actual interest earned on the Fund in fiscal year 2022-2023 to needs determined by the Council. The amount of the actual interest is recorded in the City's audited Annual Comprehensive Financial Report. The City Council must explain its decision and post its explanation on the Program's website.

Proposed code amendments

Committee action item:

Proposed code language requiring Committee review of future proposed code amendments prior to Council consideration

- G. If amendments to this Chapter are initiated by City Council, the proposed amendments will not be placed on the Council agenda until the Committee has reviewed the proposed amendments at a regular or special Committee meeting.

Draft proposal for the Committee

I propose the PCEF Committee recommend City Council amend the PCEF code, Chapter 7.07, to include the following language under PCC 7.07.050:

G. If amendments to this Chapter are initiated by City Council, the proposed amendments will not be placed on the Council agenda until the Committee has reviewed the proposed amendments at a regular or special Committee meeting.

New Committee member recommendation

Process

- **Per PCEF Code:**
 - **C.** When a Committee member resigns or the member's term expires, the Committee recommends a replacement member. The Mayor considers the Committee's recommendation when appointing Committee members.
 - **D.** The Mayor appoints Committee members, City Council confirms
- **Seeking an individual with demonstrated experience in the field of commercial renewable energy and energy efficiency.**
- **Recruitment Subcommittee (Maria, Paul, Ranfis)**
 - Opened application period (January – March 2024)
 - 18 applications received
 - Conducted interviews with high-scoring applicants May 3rd

Candidate

- Director of Energy Programs at Energy Trust of Oregon
- Over 15 years experience in the energy industry
 - Residential and commercial energy-efficiency programs for electric and gas utilities in regulated and non-regulated environments

 - Commercial and industrial programs for utilities in the mid-Atlantic region
- Additional experience includes workforce development, public housing program management, neighborhood safety, tenant rights advocacy, and human resources
