What does this mean for me?

You are receiving this notice because the Planning and Sustainability Commission (PSC) is considering proposed Zoning Code, Zoning Map, and Comprehensive Plan Map changes which, if adopted may affect the permissible uses of your property as well as other properties with the same map designation. These changes, in turn, may affect the value of your property.

The Better Housing by Design project is updating the City's multi-dwelling Zoning Code regulations to be consistent with the new 2035 Comprehensive Plan goals and policies. The proposed Zoning Code amendments include changes to allowed development intensities, regulatory standards, and affordable housing bonuses; and permit small commercial and daycare uses in certain locations.

The proposals include a revised set of multi-dwelling zones with new names and related changes to the Zoning Map and Comprehensive Plan Map and designations. **For your property, the proposal assigns the new zoning and map designations that most closely match the zoning applied to your property through the recent Map Refinement Project, which will be effective on May 24, 2018.** Changes are also proposed to where the **Design (d)** and the **Alternative Design Density (a)** overlay zones are applied.
