SUMMARY OF RESULTS

OREGON CONVENTION CENTER

The Oregon Convention Center Area has 2,242 open housing units of the unit types included in the survey. The survey included 19 multifamily buildings with 324 units, 11 hotels with 1,579 beds and four group living facilities with 339 units.

As displayed in Table 4, the total number of housing units has increased by 40 units since the last inventory in 1991. The increase is a result of the addition of 40 transient beds. No housing units were removed from the housing stock since the last inventory.



The Oregon Convention Center Area is dominated by hotel units. As shown in Exhibit 3, there is a total of 2,242 units in the Oregon Convention Center Area, of which 1,579 units are hotel units. Low income units comprise 244 units, of which 46 are subsidized and 198 are open market. In addition to low income housing units, the Oregon Convention Center Area has 142 moderate income units and 277 middle/upper income units.

The majority of low/moderate income housing in the Oregon Convention Center Area are one bedroom units. As shown in Table 5, the Oregon Convention Center Area has 92 studio units, 176 one bedroom units, 46 two bedroom units and 2 three bedroom units.

As displayed in Table 5, the Oregon Convention Center Area has no low/moderate housing units renting for \$200 or less per month. Table 5 shows there are 20 units renting for \$201 to \$250 per month, 86 units with rents in the \$251 to \$300 rent range, 57 units with rents from \$301 to \$350, 63 units renting for \$351 to \$400 and 78 units in the \$401 to \$450 rent range.

Only four middle/upper income rental housing units are located in the Oregon Convention Area. These units are all two bedroom units and rent for \$601 to \$700 per month.

The vacancy rate for low/moderate units, as shown in Exhibit 4, is 8.1 percent for the low/moderate income rental housing units for the 21 projects which information on vacancies was available. The four middle/upper income rental units in the Oregon Convention Center Area had a 50.0 percent vacancy rate. Vacancy information was not available for subsidized units.
