PROPERTY DESCRIPTION:

Site is a 82.74'x40.8' lot with all public utilities connected; concrete sidewalk, concrete driveway, retaining wall, concrete walks and steps, level yard.

Improvements consist of a 1½-story dwelling with asbestos shake siding, composition roof, built in 1895; garage and a basement, 10'x20' in size.

Interior consists of an entry hall leading into the lower living area, carpeted floors over oak, lath and plaster construction; a front room; dining room with circulator gas heater; kitchen with linoleum floors, eating space, modern sink and cabinets of metal, also fir cabinets and storage space, wired for range and refrigerator. There is a bedroom located off the dining room which has a closet. A complete bath is located off the kitchen, small size, with rim tub and white fixtures in good operating condition, open shelving. There is an entrance way out to the back yard.

There is an upstairs flat which is rented; is finished the same as the lower floor; a front room, a dining room, a bedroom off the dining room, a kitchen, and a complete bath heated by gas circulator.

There is a full cement basement which houses the garage. There is a noticeable evidence of sloping floors, indicating settling. There are also exterior signs of dry rot in the porch and steps. Gutters and downspouts are in need of repair.
