Site is a level, inside, landscaped 40'x108' lot which is approximately 1 foot above street grade with lawn, shrubs, fencing and flat concrete work. The yard is average for the district. All public utilities are connected.

Improvements consist of a 1-story and attic dwelling built in 1905 with 964 sq.ft. of main floor area. There is a living room, large dining room, fir painted kitchen with formica drainboards and good linoleum floor, old style bath with 3 fixtures and 1 large main floor bedroom. There is no central hall. Attic consists of 2 bedrooms and a sleeping room. There is a full concrete basement with oil floor furnace and electric water heater. Interior is of lath and plaster with oak and linoleum floors throughout. Exterior is of siding and shingles, composition roof, and GI gutters. Interior is superior to the exterior appearance. This is a good substantial home. There is a detached single garage in fair average condition.
