Site is a small, inside, level, landscaped 40'x40' lot with a front bank of approximately 4 feet. There is a side graveled alley of 16 feet. Onsite improvements include lawn, shrubs, fencing and flat concrete work. The small yard is in average condition. All public utilities are connected.

Improvements consist of a small 1-story dwelling built in 1890 with 664 sq.ft of main floor area. The main floor has living and dining room, 1 bedroom, bath, kitchen. The basement area has 756 sq.ft. of area with a double basement garage. Interior is of lath and plaster with oak and linoleum floors. Home is heated with an oil floor furnace. There is a 275 gal. basement oil tank. Large front covered concrete porch. Exterior is of T and G siding with aluminum shingle roof and GI gutters. Exterior needs paint. The over-all condition of the property is from fair to good.
