



SUBJECT:Response to Evaluation Report

The Quarterly Evaluation Summary in general was expected to be as it was by the Citizens Participation Department. However, in the area of Resource Utilization, I would invite input from Evaluation Department on the following:

- 1) Identify new resources where and who. (if you are aware)
- 2) When working with the Citizens Participation Working Committee, resource utilization and development of existing resources can only be a reaction of staff to citizens.

#### Example:

Consultant utilization to all nine (9) Working Committees as stated in existing project can only be used effectively if the committee is willing to except the consultant. It is one thing for staff to have consultants available and engaged and another for citizens to accept information presented.

Staff has too often been accused of "shoving material down ones throat."

The following are comments regarding recommendations made by evaluation:

- 1) Item one is directed to a Citizens Participation Task Force to study problems in the Citizens Participation structure. The Chairman of the Citizens Planning Board has appointed a Task Force that includes six (6) members from the Citizens Planning Board and the three (3) officers (Chairman, Vice-Chairman, and Secretary) of the Citizens Participation Working Committee. Co-Chairman of the Task Force met and will have an official meeting soon, where staff will participate. While working closely with the Evaluator for Citizens Participation vibrations are now very clear that the Evaluation Department is requesting to be a part of the technical assistance that is necessary for this Task Force. I agree, and appropriate action will be taken.
- 2) Funds are available for training of staff in community structure analysis, community organizing and public relations work. This will be explored for the remaining time in Second Action Year, and a planned activity for the day-to-day process within the Department.

- 3) Staff seminars are held weekly to increase the Departments' awareness and involvement in community problems. This is a major part of Citizens Participation Departments' staff meetings. Planning Assistants meet with Community Organizers with the Program Specialist monitoring all activity. This process is inclusive of problem solving, methods of approach to reach residents, and issues to be discussed.
- 4) My recommendations for a solution to coordination and flow of information between Citizens Participation and other CDA Departments is that this be facilitated at the Coordinators/ Supervisors weekly staff meetings. If requests for services are pronounced at this meeting I will be able to coordinate the request/activity effectively.



I have been informed by Lt. Smith, Police Community Relations Director, of the Public Safety Advisory Committee's intention to send a delegation of three members to San Francisco in the latter part of July to view PCR projects in other cities. I would like to suggest that a member of the Law and Justice Working Committee be designated to accompany the PSAC delegation on this trip.

This request for a Law and Justice representative does not arise from a mere desire to go. Rather, in visiting Police Community Relations projects in other cities, we need to view them from both PSAC and the Law and Justice Working Committee's perspectives. The PSAC delegation can benefit greatly from studying how other groups can best assist police departments through citizen action. The Law and Justice Working Committee's representative can benefit by viewing the community participation structures and the planning process.

I feel this would be an excellent opportunity for these two committees to work together for the betterment of the Police Community Relations project in Portland. By meeting with various community groups, this can also serve to strengthen the citizen participation in our working committees.

If I were chosen to act as the Law and Justice representative, I would certainly take the time to get in touch with new ideas in related fields. I would very much like the opportunity to meet with San Francisco's Sheriff Honginston concerning rehabilitation procedures, since convict rehabilitation is of major concern to the Law & Justice Working Committee.

I would like to request that you appoint someone from the Law and Justice Working Committee to accompany the PSAC delegation on their visit to PCR projects in the San Francisco area. Since I understand that PCR budget can only cover the cost of sending three persons, I would suggest that Model Cities administrative travel funds be used to cover the cost of sending the fourth representative.

Effective the first of the year, the State Department of Agriculture began inspection of food processing and handling establishments in the City of Portland, and, on the first of July, we will be responsible for the inspection of all dairy processing plants.

Because of this added responsibility, the changeover of administration, and the implications this program has to the health and safety of the citizens of Portland, we have endeavored to inform the citizens of our activities and seek their cooperation through our Board of Agriculture member, Mrs. Clara Peoples, Community Care Association, Inc.

Due to the increased awareness upon the part of citizens, a direct request has been expressed to us to encourage young people from minority groups to become food sanitarians. We seek to create such an opportunity for these people to help them become more familiar with the food inspection and consumer protection program of the State Department of Agriculture, and, through this exposure, the individual would have an opportunity to evaluate the possibility of preparing himself as a food sanitarian.

The present minimum qualifications for a Food Sanitarian state the individual must have a Bachelor's degree with 45 quarter hours of science courses relating to environmental sanitation and two years' experience in environmental sanitation or related

activities. Science courses relating to environmental sanitation include courses in public or community health or in sanitary, biological or physical sciences.

Program areas for sanitarians in the Department of Agriculture include dairy production and processing, egg production, grading and processing, bakery production, carbonated beverage bottling, and food service and processing.

The Department of Agriculture is desirous of involving young people in our food inspection work and believe this would be a very exciting and challenging career for minority peoples. However, the Department is without funds nor can funds be awarded for such a work-study program. We must also seek reimbursement for time and other extra costs and develop a plan which avoids interruption of our regular duties and our specific legal responsibilities.

If a grant could be made of Model Cities funds for this purpose, we would be very willing to initiate a career awareness program for minority students, assuming there are no statutory restrictions of which we are unaware.

I am looking forward to your reply as to the possibility of being granted funds for this work-study program.

All persons whose telephone numbers began with 280, 281, 282, 284, 287 and 288 will be entitled to use this service. This means that even though rates may go up, people in the above areas will still be able to have telephone service at a price they can afford to pay. Nowhere else in the city or the state will this service be available.

Finally, we are presently engaged in conferences with the top administrators of Pacific Northwest Bell in an effort which we feel will be successful in bringing about a change in the company's arbitrary actions in requiring deposits which are unreasonable, in its failure to make credit checks for telephone subscribers and in their practice of summarily disconnecting telephone service without regards to the circumstances of the subscriber. When we have concluded these conferences with the company we shall send the full report of the results obtained to the board for its information.

All persons whose telephone numbers began with 280, 281, 282, 284, 287 and 288 will be entitled to use this service. This means that even though rates may go up, people in the above areas will still be able to have telephone service at a price they can afford to pay. Nowhere else in the city or the state will this service be available.

Finally, we are presently engaged in conferences with the top administrators of Pacific Northwest Bell in an effort which we feel will be successful in bringing about a change in the company's arbitrary actions in requiring deposits which are unreasonable, in its failure to make credit checks for telephone subscribers and in their practice of summarily disconnecting telephone service without regards to the circumstances of the subscriber. When we have concluded these conferences with the company we shall send the full report of the results obtained to the board for its information.

The Metropolitan 4-C Council is currently in a state of crisis. At a press conference October 12, 4-C Central Administrator, Ed Klumpp, and Ms. Frances K. Ousley, Chairman of the Confederation of Provider Agencies, released the following information:

"At this time it is a foregone conclusion that Federal legislation coupled with revenue sharing with limitation on funds for social services, including Title IV A Social Security Amendments, will pass the Congress. This legislation will force the Oregon State Department of Human Resources to make cuts in the social services programs. Strong indications are that Children's Services Division will propose to reduce its budget by making drastic cuts in Federal funds available for day care programs."

Unofficial figures prepared by Metro 4-C (attached) show that the anticipated funding level of \$4,385,000 has been reduced by almost \$2 million, thus leaving 4-C far short of the necessary funds with which to operate their programs. Metro 4-C's anticipated budget now appears to be \$2.4 million, although these figures are mere conjecture. To date during Third Action Year, 4-C has spent \$1.2 million, leaving a balance of approximately \$1.27 million. With the current rate of spending at \$400,000 per month, 4-C will not be able to operate at its current level for more than 60 to 90 days.

While the figures prepared by 4-C appear extremely grim for local child care services, the figures are not a matter of public record yet and 4-C is attempting to affect State decisions on future fundings, and to request that the State spread cuts evenly among programs.

The primary vehicles for influencing State funding decisions will be the parent councils at each day care center and their composite body, the Confederation of Provider Agencies. Representatives from the central 4-C staff, the Central 4-C Council and the Confederation of Provider Agencies met with representatives from the Children's Services Division in Salem today to discuss the 4-C dilemma.

Effect of budget cuts on 4-C day care programs in the Model Cities Area:

1. Approximately 2,000 children are now receiving day care services in the Model Neighborhood. There are roughly 1,300 enrolled in before and after school supervisory day care, 200 enrolled in the family day and night care program, 160 enrolled in the pre-school expansion program, and 300 enrolled in small group day care centers. The degree to which cuts may be necessary

has not yet been determined. However, data on families receiving services is now being gathered and will be used to reassess the needs of the families.

- 2. If cuts are inevitable, the sliding fee scale through which some parents pay for child care may be tightened, thus bringing in more revenue to 4-C.
- 3. Some administrative overhead may be reduced to include a combination of bookkeeping contracts, a reduced transportation component and a review of all staff positions.

As previously stated, the actual amount of budget cuts has not yet been determined; however they do appear inevitable. Decisions on cuts will be made by the Central 4-C Board with input from the parent councils at each center. No decisions will be made until official word is received from the State on the degree of cuts. As decisions are made, both CDA staff and the Citizens Planning Board will be consulted for input into those decisions.

This office has attempted to trace the telegram through Western Union, but found that the person who sent the telegram paid cash and left no name whatsoever. Therefore it is extremely difficult for this office to respond directly to the alleged residents concerned. I do, however, want to make this information available to your office, the staff of Model Cities, and the City Hall press, as well as Commissioner Neil Goldschmidt.

On November 20, 1972, the Project Directors of the Social Environment Program held their regular monthly Project Directors' Meeting.

The agenda of the meeting included a discussion on the suggestion made by the Social Services Working Committee to the CPB in a letter dated November 9, 1972, (see attached) in reference to the proposed 25% reduction in budgets for all projects assigned to the Social Services Working Committee.

The areas of discussion included the following: Would the proposed reduction help or hurt projects seeking other additional sources of funding? How would the money saved from the project be spent? What affect would this 25% loss have on projects already funded and operated on a "bare bones" budget? Would this 25% cutback added to the already proposed Metro 4-C proposed budget cuts seriously damage the Model Cities Child Care 4-C Programs? Would local or federal agencies be able to provide this additional 25% funding?

Also discussed was the concern over the lack of available money to fund Social Services Programs due to the 26.5 million dollar ceiling placed by Federal Legislation on monies for the State of Oregon.

After a lengthy discussion, the following actions were taken by the Project Directors:

- 1. Voted to oppose the suggested 25% budget cut.
- Agreed to hold a meeting with Mr. Dick Celsi, Chairman of the Social Services Working Committee, at the earliest possible date to clarify the intent of the committee's suggestion. (Mr. Celsi will be unable to meet with the Directors prior to November 28, 1972.)

- Directors are opposed to any reduction in budgets, not only in programs assigned to the Social Services Working Committee, but in any other program contracted by CDA.
- 4. The Directors instructed the Acting Social Coordinator to draft a letter to Mr. LeRoy Patton, Chairman of the Citizens Planning Board, expressing the enclosed concerns.
- 5. This letter is to be attached to Mr. Celsi's letter to the Chairman of the CPB and made a part of all discussions on the proposed suggestion for a 25% reduction in budgets.
- 6. Copies of this letter must be sent to Mr. Charles Jordan, Acting Director of the Bureau of Human Resources; Mr. Andrew Raubeson, Acting Director of Model Cities; and to the Executive Committee of the Citizens Planning Board.

#### Background on CDA Letter #11:

All Model Cities programs nationally must demonstrate a substantial effort to insure the employment of Model Neighborhood residents in projects receiving HUD funding.

CDA Letter #11 specifically outlines HUD policy in regards to the employment of neighborhood residents. Each comprehensive city demonstration program must provide "...maximum opportunities for employing residents of the area in all phases of the program and enlarged opportunities for work and training..." and that it "...make marked progress in reducing under-employment and enforced idleness..."

This statutory requirement must be complied with in the filling of professional and non-professional level employment opportunities in programs receiving HUD money. Operating agencies shall be incorporated into an agreement on specific employment and training goals.

The city government submitting a city comprehensive demonstration program has the responsibility to assure the implementation of this policy and that programs receiving HUD funds grant preference in hiring and training to Model Neighborhood residents.

In attaining these objectives, each city comprehensive demonstration program component will indicate procedures for hiring Model Neighborhood residents through recruitment, selection, pre-employment training, on-the-job training, and upgrading. Procedures to remove barriers to the employment and upgrading of Model Neighborhood residents must be designed. The CDA must commit itself to reform employment systems which impede successful employment of Model Neighborhood residents.

CDA Letter #11 further specifies that components of city comprehensive demonstration program operated by a city department shall incorporate

such jobs into the city's regular civil service system. The city must demonstrate a good faith effort to reform civil service requirements which prevent the entrance of Model Neighborhood residents into effective participation in the operation of local government.

It is further the responsibility of the CDA to ensure that operating agencies develop specific programs to upgrade employees retained in para-professional job classifications.

CDA Letter #11 also specifies that Model Neighborhood residents be employed in construction crafts and trades in which construction projects are receiving HUD Funds.

#### Committee Action

- 1) A joint meeting between members of the Human Resources Task Force, Personnel Hiring Committee, and the Employment Working Committee was held on September 18, 1972, to review Commissioner Goldschmidt's plan to incorporate CDA employees into civil service. A motion was made and passed to support the plan in concept.
- 2) The Employment Working Committee passed a motion on October 5, 1972, to hire a Central Administrator to be retained on CDA staff to monitor, design, and supervise the development and implementation of resident employment and training plans.
- 3) At a meeting on November 15, 1972, the Employment Working Committee reviewed and accepted a Position Paper on the Resident Employment and Training Plan.
- 4) On December 13, 1972, the Employment Working Committee passed and accepted a job description for the Personnel and Training Supervisor, whose duties will be to monitor, design, and implement the development of employment and training programs for Model Neighborhood residents.

#### Staff Recommendations:

The City Demonstration Agency staff is submitting this material for information purposes at this time. Future action to be taken will include approval of hiring a Personnel and Training Supervisor to begin development and design of resident employment and training goals and objectives.
