Dear Mr. Lathan:

I am writing in response to your letter of November 8, 1972 addressed to Ms. Edna Robertson. It is my intention to attend the November 15, 1972 meeting of your committee at which time we can discuss the issues you raise at some length, however, I will endeavor to respond to each point below.

- 1. Our affirmative action plan was in response to a requirement set forth by the Metropolitan Human Relations Commission under the overall City Plan which is concerned with full-time employees of the City. There was no intent on our part to exclude the Community Organizers.
- They are not members of the Union. The agency does not set the terms of union eligibility. The union's labor agreement with the city and their bargaining conditions cover only full-time employees.
- 3. Yes, Community Organizers have the same rights for upgrading within the agency. In fact, two community organizers have been promoted within the agency.
- There is no "mechanism" per se, however, the C.P. Coordinator has included the Community Organizers in the staff training conducted in that department.
- 5. The office manager is currently researching the number of community organizers who have been employed and I will have that information on the 15th. As previously mentioned, two community organizers have been promoted from within and several others have used their experience at Model Cities to qualify for better jobs in other agencies.
